Road Traffic (Vehicles) (Taxing) Act 2008

An Act to impose certain charges prescribed under the *Road Traffic (Vehicles) Act* ~~2008~~2012 section 7(3) to the extent that any such charge may be a tax.

[Long title amended: No. 8 of 2012 s. 237.]

The Parliament of Western Australia enacts as follows:

1. Short title

This is the *Road Traffic (Vehicles) (Taxing) Act 2008*.

2. Commencement

This Act comes into operation as follows:

- (a) sections 1 and 2 — on the day on which this Act receives the Royal Assent;
- (b) section 3 — on the day fixed under the *Road Traffic (Administration) Act 2008* section 2(b).
