## Motor Vehicle Dealers (Prescribed Vehicles) Regulations 1974

#### 1. Citation

These regulations may be cited as the *Motor Vehicle Dealers* (*Prescribed Vehicles*) Regulations 1974 <sup>1</sup>.

### 2. Terms used

In these regulations —

*caravan* means a trailer, including a camper trailer, fitted for human habitation in the course of a journey;

*goods vehicle* means a motor vehicle designed to be used primarily to carry goods or materials used in any trade, business or industry;

*motor vehicle* has the same meaning asgiven in the *Road Traffic* (Administration) Act 19742008 section 4;

*trailer* means a vehicle designed to be drawn by a motor vehicle.

## 3. Prescribed vehicles under section 5(3)(e)

Vehicles of a type or class set out in the table to this regulation are prescribed vehicles for the purposes of section 5(3)(e) of the Act.

#### **Table**

- 1. Caravans
- 2. Four wheel drive vehicles
- 3. Goods vehicles
- 4. Passenger vans used wholly or principally for the conveyance of persons and sold with a seating capacity not exceeding 8 persons.

#### 4. Regulation 2 amended

In regulation 2 in the definition of *motor vehicle* delete "same meaning as in the *Road Traffic Act 1974*;" and insert:

meaning given in the *Road Traffic (Administration) Act 2008* section 4;
