## **Electoral (Ballot Paper Forms) Regulations 1990**

#### 1. Citation

These regulations may be cited as the *Electoral (Ballot Paper Forms) Regulations 1990*<sup>1</sup>.

#### 2. Form of ballot papers

- (1) Ballot papers for elections shall be in the appropriate form set out in Schedule 1.
- (2) The forms in Schedule 1 replace the forms set out in Schedule 3 to the Act.


Form A: Ballot paper for an election in a region if there are 3 or more candidates and no groups, and one or more voting tickets are registered.



- (h) Insert name of political party, or composite name of political parties, or "Independent", if to be printed.

- an election in a region if there are no groups and no voting tickets are registered,

if there are 3 or more candidates.




