Petroleum (Submerged Lands) Registration Fees Regulations 1990

1. Citation

These regulations may be cited as the *Petroleum (Submerged Lands) Registration Fees Regulations 1990*¹.

2. Commencement

These regulations shall come into operation on the commencement of the *Petroleum (Submerged Lands) Registration Fees Amendment Act 1990*¹.

3. Amounts prescribed (Act s. 4)

- (1) For the purposes of section 4(2) of the Act, the prescribed amount is an amount of \$5 ~~046~~102.00.
- (2) For the purposes of section 4(3) of the Act, the prescribed amount is an amount of \$5 ~~046~~102.00.
- (3) For the purposes of section 4(4) of the Act, the prescribed amount is an amount of \$7 ~~677~~761.00.
- (4) For the purposes for section 4(6) of the Act, the prescribed amount is an amount of \$5 ~~046~~102.00.

- (5) For the purposes of section 4(7) of the Act, the prescribed amount is an amount of \$7 ~~677~~761.00.
