Murdoch University Act 1973

An Act to establish and incorporate Murdoch University, to make provision for the government of the University, and for incidental and other purposes.

Part 1 — Preliminary

1. Short title

This Act may be cited as the Murdoch University Act 1973 ¹.

2. Commencement

This Act shall come into operation on a date to be fixed by proclamation ¹.

3. Terms used

(1) In this Act, unless the context otherwise requires — *absolute majority* means a majority of all the persons for the time being holding office;

Academic Council means the Council established in accordance with section 21;

casual vacancy means a vacancy arising in the office of a member of the Senate otherwise than by reason of the effluxion of time;

Chancellor means the Chancellor of the University;

Convocation Deputy Chancellor means the body established by that name pursuant to section 19; Deputy Chancellor of the University;

examination means an examination conducted by the University or an examination conducted by any other person or body prescribed by the Statutes as a person or body authorised to conduct examinations for the University;

Guild means the Guild of Students of Murdoch University incorporated under section 20;

prescribed means prescribed by this Act, a by-law or Statute, as is required;

Pro-Chancellor means the Pro-Chancellor of the University;

regulation means a regulation made under section 26;

section residential accommodation —

- (a) means sectionany form of this Actaccommodation (including, without limitation, a residential college, hostel, hall of residence or form of independent living); and
- (b) includes facilities that are
 - (i) ancillary to residential accommodation; and
 - (ii) primarily for the use of staff of the University, or students, or both;

Statute means a Statute of the University in force pursuant to this Act;

student means a student enrolled in the University;

Treasurer means the person holding or acting in the office of Treasurer of the State;

University land means —

- (a) the land described in certificate of title Vol 2812 Folio 355; and
- (b) any land vested in the University under section 28(1);

Vice-Chancellor means the Vice-Chancellor of the University; *Visitor* means the Visitor of the University.

(2) Any question arising as to whether a person is or is not a member of the academic <u>or other</u> staff, or an officer or <u>servantemployee</u> of the University, shall be determined by the Senate and the decision of the Senate thereon is final.

Part 2 — Murdoch University

4. **Murdoch University**

- (1) There shall be in the State of Western Australia a university, to be called "Murdoch University".
- The University shall be a body corporate and shall have (2) perpetual succession and an official seal.
- Subject to the provisions of this Act, the University (3)
 - may, in its corporate name acquire, accept, hold, deal with, charge, or dispose of real and personal property; and
 - is capable of suing and being sued in its corporate name (b) and of doing and suffering all such other acts and things as bodies corporate may by law do and suffer.
- (4) All courts, judges and persons acting judicially shall take notice of the official seal of the University affixed to a document and shall presume that it was duly affixed.
- The official seal of the University shall be kept in strict custody (5) and shall not be used except in accordance with the direction of the Chancellor or as is prescribed by Statute.


5. Objects of University

The objects of the University shall be the advancement of learning and knowledge, and the provision of university education.

Functions of University 6.

- (1) The functions of the University shall-include the following
 - to establish provide courses of study appropriate to a university, and maintain such schools of study as are prescribed by Statute; other tertiary courses;

The University shall have has all such the powers, rights and (2) privileges as that are reasonably necessary to enable it to carry out its functions.

No discrimination

- Men and women shall be equally eligible for any office or appointment in the University and for membership of any of its constituent bodies and all degrees and courses of study in the University shall be open to men and women alike.
- No religious, racial or political test shall be imposed upon any person in order to entitle him or her to be admitted as a student or other member of the (3) The University may carry out its functions and exercise its powers, including the power to enter into business arrangements, within or outside the State. Power of University to provide residential accommodation 8A. for staff and students

- The University, or as a member of the academic or other may provide residential accommodation for staff of the University, or students, or both.
- The restrictions imposed by section 29(1)(ga) do not apply to the lease of any part of the land referred to hold office in or to graduate at in section 29(1)(ga) if the purpose of the lease is the provision of residential accommodation in accordance with this section.

Part 3 — Constitution of University, or to hold any advantage or privilege thereof.

8. **Constitution**

The University shall consist of —

- the Senate; and (a)
- such members of the academic and other staff of the (b) University as are prescribed by Statute; and
- Convocation; graduates of the University; and
- the students for the time being; and (d)
- such other persons, if any, as are prescribed by Statute.

9. Visitor

- The Governor shall be is the Visitor of the University, and has (1) authority, as and when he or she thinks fit, to do all thingsthe functions that pertain to the office of Visitors usually have.
- As Visitor-of a university as well as such particular powers as may be conferred upon him by this Act or any Statute.
- (2) For the purposes of this section, the Governor is authorised to may act without the requirement of obtaining the advice and consent of the Executive Council, section 23 of the Interpretation Act 1918², notwithstanding.

10. Chancellor

11. **Pro-Deputy Chancellor**

- There shall be a Pro-Deputy Chancellor of the University who (1) shall be elected by the members of the Senate from amongst their number.
- Subject to subsection (2a) and section 15, the Pro-Deputy (2) Chancellor holds office for thea term of 2not exceeding 3 years from to be determined by the date of his election Senate and is eligible for re-election.
- (2a) The Pro-Deputy Chancellor ceases to hold office if he ceases to be a member of the Senate.
- In the absence of the Chancellor, or where there is a vacancy in (3) the office of Chancellor, the Pro-Deputy Chancellor shall preside at all meetings of the Senate at which hethe Deputy Chancellor is present and may exercise all the functions of the Chancellor.

12. Senate

- The membership of Senate shall consist of consists of the (1) following members –
 - the persons holding or acting in the office of Chancellor and of:
 - the Vice-Chancellor-respectively; (b)
 - 3 persons (c) one person who is a member of the academic staff of the University and who is elected by and from the members of the full-time the academic staff of the University in the manner prescribed by Statute;
 - (ed) one person who is a member of the non-academic salaried staff of the University, and who is elected by and from the full-time officers and servants of the University who are not members of the full-time academic the non-academic salaried staff of the University in the manner prescribed by Statute;
 - 2- persons who are students (de)
 - one of whom is an undergraduate student and who is elected by the undergraduate students in the manner prescribed by Statute; and
 - one of whom is a postgraduate student and from the who is elected by the postgraduate students in the manner prescribed by Statute;
 - 2- persons who are graduates of the University and who (ef) are elected by Convocation from the members graduates of Convocation the University in the manner prescribed by Statute;
 - -6g) 3 members appointed by the Governor; on the recommendation of the Minister;

- (g) up to 3h) not more than 5 persons as are co-opted to serve as members of the Senate by an absolute majority of the other members.
- (i) the person for the time being the President of the Academic Council.
- (1A) The fact that a person holds an elective office (for example, an elective office of the Guild) does not disqualify that person from being appointed or holding office under subsection (1).
 - (2) The following persons are not eligible to be a member of the Senate under subsection (1)(e), (f), (g) or (gh)
 - (a) a full-time member of the staff of the University;
 - (b) a part-time or casual employee of the University who works for at least 50% of the minimum time required to be worked by a full-time member of staff;
 - (c) a student.
 - (2a) Of the members of the Senate
 - (a) at least 2 must have financial expertise (as demonstrated by relevant qualifications and by experience in financial management at a senior level in the public or private sector); and
 - (b) at least one must have commercial expertise (as demonstrated by relevant experience at a senior level in the public or private sector),


and the member mentioned in paragraph (b) may also be one of the members mentioned in paragraph (a).

- (3) The Senate may, from time to time, appoint a committee or committees, which may comprise persons who are not members of the Senate, to advise the Senate on such matters relating to its functions as are referred by the Senate to a committee.
- (4) Subject to the requirements as to a quorum, the Senate or a committee has power to act notwithstanding any vacancy among

- its members or that any number of members has not been appointed or elected at the time of the proceedings.
- All acts done at any meeting of the Senate, or a committee, shall (5) notwithstanding that it is afterwards discovered that there was some defect in the election, appointment or qualification of a person purporting to be a member, be as valid as if that defect had not existed.
- The quorum to constitute a meeting of the Senate may be (6) prescribed by Statute but shall not be less than 8 persons.
- Each member shall have a deliberative vote at any meeting of (7) the Senate and, unless otherwise provided by Statute, where there is an equality of votes the person presiding has a casting vote as well as a deliberative vote.
- (8) Subject to this Act, and to any Statute, the Senate may determine its own procedure.

- The Senate must establish and maintain a committee of the Senate called the Nominations Committee.
- (2)...) The Nominations Committee is to consist of not more than 6 members of the Senate appointed by the Senate.
- Tenure of office
- (1) Subject to sections 15 and 16—
- The following members are not eligible to be appointed to the Nominations Committee —
 - (a) the Vice-Chancellor;



The Nominations Committee may regulate its own procedure, but it must comply with any direction given by the Senate. [Section 13 inserted by No. 32 of 2016 s. 100.]

Term of office of members 14.

- Subject to section 15 (1)
 - (a) a member appointed under section 12(1)(g) or (h) holds office for a period of 3 years, commencing on the day of their appointment, unless a shorter term of office by election, appointment or co-option for 3 successive terms is not thereafter is specified under subsection (4);
 - a member elected under section 12(1)(c), (d) or (f), holds office for a period of 3 years, commencing on the day their election takes effect, unless a shorter term of office is specified under subsection (5);
 - a member elected under section 12(1)(e) holds office for a period of one year commencing on the day their election takes effect, unless a shorter term of office is specified under subsection (5).
- An appointed (which includes coopted) or elected member, on the expiry of their term of office
 - may be reappointed or re-elected, if they continue to be qualified under section 12; but
 - on the expiry of a third successive term of office (of whatever duration), they are not eligible to hold office as a member until the expiry of a period of 12 months from the last day on which he was a member have elapsed after that expiry.
- However, a member elected under section 12(1)(e) may be re-elected once, but only once, on the expiry of their term of office, if they continue to be qualified under section 12.

- The Governor or the Senate may, when appointing a person as a (4) member, specify a shorter term of office where an appointment for a shorter term is desirable to ensure that
 - the terms of office of members expire at intervals that will produce reasonable continuity of membership; or
 - the terms of office expire on dates that afford the (b) convenience of uniformity.
- The Senate may, before an election is held for the purposes of section 12(1), specify that the election of a person is for a shorter term of office where election for a shorter term is desirable for a reason referred to in subsection (4).

15. Resignation, disqualification and vacation of office

- The Chancellor may resign his their office by writing under his (1) hand addressed written notice given to and accepted by the Visitor. Minister.
- (2) The Pro-Deputy Chancellor or a member of the Senate may resign histheir office by writing under his hand addressed written notice given to the Chancellor, and every such resignation takes effect when it is received at the office of the University Minister.
- A person who (3)
 - is a person in respect of whom an administration order is in force under Part 6 of the Guardianship and Administration Act 1990: or
 - is, according to the *Interpretation Act 1984* section 13D, (b) a bankrupt or a person whose affairs are under insolvency laws; or

- (c) is convicted of an indictable offence; or
- (ca) is, or becomes, disqualified from managing corporations under Part 2D.6 of the *Corporations Act 2001* of the Commonwealth; or
- (d) has histheir appointment terminated by the Governor for inability, inefficiency or misbehaviour,

is not capable of holding office under this Act and on the happening of any such event <u>histhe person's</u> office becomes vacant and <u>hethe person</u> is not eligible for <u>re-election or</u> re-appointment.

- (3a) A member of the Senate who is removed from office by the Senate under section 15A is not eligible to be a member again until
 - (a) in the case of a member elected by the students, one year has elapsed since the removal; or
 - (b) in the case of any other member, 3 years have elapsed since the removal.
- (4) Where If a person was elected to who is a member of the Senate by and from amongst
 - (a) the members of the full-time academic staff of the University; or
 - (b) the students,

and he ceases to be a member of that staff or a student, as the case may be, hishold the required qualification under section 12 for being a member, the person's office as a member of the Senate becomes vacant.

(5) The office of a member of the Senate shall be vacated if, without leave obtained from the Senate, hethe member has been absent from all meetings of the Senate for 6 consecutive months, or has been absent from more than one-half of the meetings of the Senate during any period of 12 consecutive months.

15A. Removal of Senate members for breach of certain duties and suspension pending removal

- (1) The Senate may
 - remove from office a member of the Senate for breach of a duty mentioned in Schedule 1 clause 1(1), 2(1) or 3;
 - suspend from office a member of the Senate who is (b) alleged to have breached a duty mentioned in Schedule 1 clause 1(1), 2(1) or 3 until the motion for removal is put to the vote.
- (2) The removal or suspension from office may be effected only at a meeting of the Senate of which notice (including notice of the motion that the member concerned be removed or suspended from office for breach of duty) was duly given.
- Despite section 12(6), the removal or suspension from office may be effected only if the motion for removal or suspension is supported by a majority comprising enough of the members for the time being of the Senate for their number to be at least 2/3 two-thirds of the total number of offices (whether vacant or not) of member of the Senate.
- (4) The motion for removal or suspension must not be put to the vote of the meeting unless the member concerned has been given a reasonable opportunity to reply to the motion at the meeting, either orally or in writing.
- (5) If the member to whom the motion for removal or suspension refers does not attend the meeting, a reasonable opportunity to reply to the motion is to be taken to have been given if notice of the meeting has been duly given.
- (6) The Senate cannot remove or suspend from office a member of the Senate for breach of a duty mentioned in Schedule 1 clause 1(1), 2(1) or 3 except in accordance with this section.

- (7) A person must not vote on any question relating to the person's removal or suspension from office by the Senate for the breach of a duty mentioned in Schedule 1 clause 1(1), 2(1) or 3, or be present while the matter is being considered at a meeting.
- This section applies only in relation to a breach of a duty (8) mentioned in Schedule 1 clause 1(1), 2(1) or 3 that occurs after the Universities Legislation Amendment Act 2005 comes into operation ¹.
- (9) A person does not breach a duty mentioned in Schedule 1 clause 1(1)(a), (b) or (c) by doing or omitting to do anything in compliance with a direction given to the person in exercise of a power conferred by a written law.
- Subsection (9) does not extend to the manner in which a thing is (10)done or omitted if it is done or omitted in a manner that is contrary to Schedule 1 clause 1(1)(a), (b) or (c) and the direction did not require that it be done in that manner.
- (11)The suspension from office of a member of the Senate does not create a vacancy in that office.

16. Appointment to easual Casual vacancies

- A If a casual vacancy occurs in the office of Chancellor, Pro-Chancellor or a member of the Senate which occurs otherwise than by, the effluxion of time vacancy is a casual vacancy and shall to be filled as it occurs.
- A casual vacancy in an office to which a person may be elected under this Act shall be filled by the election of another person to same manner as if that office by the persons so authorised to elect to that office, but it shall not be necessary to hold any such election to fill a casual vacancy where the unexpired portion of themember's term of office left vacant is less than 6 monthshad expired.

- A casual vacancy in an office to which a person may be appointed under this Act shall be filled by the appointment to that office of another person by the person or persons holding the power to appoint.
- Where, in the opinion of the Governor, a casual vacancy is not filled within 6 months of the date on which it was required to be filled, he may appoint a qualified person to that vacancy, and any such appointment is valid and effective for the purposes of this Act.
- A person who succeeds to a casual vacancy holds office only for the residue of the term of office commenced by his predecessor and remaining unexpired.

17. Functions of Senate, its powers and duties

- (1) The governing body of the University shall be the Senate.
- Subject to the provisions of this Act, the Senate (2)
 - shall have the entire control and management of the affairs and concerns of the University and may act in all matters concerning the University in the manner which to it appears most likely to promote the objects and interests of the University;
 - shall appoint, and may vary or terminate the (b) appointment of, the academic and other staff, officers and servants employees of the University;
 - in the name and on behalf of the University and in accordance with the Statutes and regulations relating theretomade under section 26, shall have the power to award degrees and other academic distinctions, and may grant honorary degrees and other distinctions on approved persons, and may for good cause deprive persons of any degree or other distinction granted or awarded by the University;

- (d) in the name and on behalf of the University, may, with the approval of the Governor and in the manner and to the extent by this Act provided, make, alter and repeal by-laws for the purpose of managing, preserving and protecting the lands of the University and regulating the use of those lands by any person and the conduct of persons when on or upon those lands;
- (e) may, with the approval of the Governor and in the manner by this Act provided, make, alter and repeal Statutes with respect to the constitution, management, good government and discipline of the University.

17B. Relief of Senate members from liability

If, in any civil proceeding against a person who is or was a member of the Senate for negligence, default, breach of trust or breach of duty in the person's capacity as a member of the Senate, it appears to the court that the person—

- (a) is, or may be, liable in respect of the negligence, default or breach:
- (b) has acted honestly; and
- ought fairly to be excused for the negligence, default or breach having regard to all the circumstances of the case, including those connected with the person's appointment,

the court may relieve the person either wholly or partly from liability on such terms as the court thinks fit.

18. Delegation by Senate

- (1) The Senate may, in relation to any matter or class of matters, or in relation to any activity or function of the University, by resolution, delegate all or any of its powers and functions under this Act (except this power of delegation and its powers in relation to the making of by-laws, Statutes, and regulations made under section 26) to any —
 - (a) member of the Senate; or
 - committee, council or other body; or (b)
 - (b) officer or officers,

of the University-; or

- (c) officer of the University.
- EveryThe Senate may by resolution revoke a delegation given (2) under this section shall.
- A resolution delegating a power, authority, duty or function may authorise the delegate to further delegate the delegated power, authority, duty or function to a person or body.
- A subdelegation under this section must be revocable by resolution of the Senate, in writing.
- The *Interpretation Act 1984* sections 58 and no 59 apply to and in relation to a subdelegation under this section in the same way that they apply to and in relation to a delegation shall prevent the exercise of any power or function by the Senategiven under this section.

19. Convocation

- Convocation shall be constituted on 1 July 1980. (1)
- Convocation shall consist of (2)
 - all persons who are or have been members of the Senate;

- (b) all persons admitted to a degree awarded by the University of the status of a Bachelor, a Master or a Doctor;
- (c) all persons who are members of the academic staff of the University on the basis of their full-time employment by the University, and such other members of the staff of the University as may be prescribed by Statute; and
- (d) such other persons as may be prescribed by Statute.
- (3) The functions of Convocation shall include
 - (a) the submission for the consideration of the Senate of such proposals as Convocation thinks fit with respect to the welfare of the University;
 - (b) the furnishing to the Senate of reports on matters referred to it by the Senate for consideration; and
 - (c) such other acts or matters as may be conferred or imposed by Statute,

and Convocation shall have all such powers as may be necessary to discharge its functions.

(4) Meetings of Convocation shall be convened and the proceedings of Convocation regulated as may be prescribed by Statute, and where not so prescribed as Convocation may determine.

20. Guild of Students

- (1) The Guild of Students of Murdoch University shall be established as a body corporate under that name, and by virtue of this section, on 1 September 1976, unless prior to that date the Guild is so established as a body corporate by the Senate, which the Senate is hereby empowered to do.
- (2) The Guild shall be an organized association of students for the furthering of the common interests of its members, and shall be the recognised means of communication between students and the Senate, in accordance with any Statutes that the Senate makes.

- (2a) Any student is eligible to be a member of the Guild.
- (2b) The University shall not act in a way that may dissuade or discourage a student, or person seeking enrolment as a student, from being or becoming a member of the Guild.
- [(2c) deleted]
- (2d) No academic benefit, right or privilege shall be denied to or withheld from any student by reason of that student <u>being or</u> not being a member of the Guild.
 - (3) The functions of the Guild, its powers and duties, authorities, obligations and privileges shall be prescribed by Statute together with such other matters as are considered by the Senate to be necessary or desirable to ensure the effective exercise of those functions.
 - (4) When established as a body corporate the Guild in its corporate name shall have perpetual succession and an official seal, may sue and be sued and, subject to the Statutes, may do and suffer such other acts and things as bodies corporate may by law do and suffer.
 - (5) A student becomes a member of the Guild upon enrolment, for the period of enrolment, unless at the time of enrolment that student elects not to become a member.
 - (6) Subject to subsection (7), a student becomes a member of the Guild upon enrolment, for the period of enrolment.
 - (7) A student may
 - (a) elect at the time of enrolment not to become a member of the Guild; and
 - (b) resign at any time as a member of the Guild.







- (7) A relevant lease is, and is taken always to have been, as valid as if—
 - (a) any approval of the lease required under section 29(1)(f) as in force immediately before commencement day had been obtained: and
 - any requirement under the Land Administration Act 1997 section 75 for the written permission of the Minister responsible for the administration of that Act to be obtained for the transfer of the interest under the lease had been complied with.

 - (c) must at all times act in the best interests of the University and give precedence to the interests of the University over the interests of any person appointing or electing a member of the Senate;
 - (d) must not, whether within or outside the State, make improper use of information acquired by virtue of the position of member of the Senate to gain, directly or indirectly, an advantage for any person or to cause detriment to the University;
 - (e) must not, whether within or outside the State, make improper use of the position of member of the Senate to gain, directly or indirectly, an advantage for any person or to cause detriment to the University.
- (2) Nothing in subclause (1) or section 15A or 17A affects
 - (a) any other duty a member of the Senate may have under any other law; or
 - (b) the operation of any other law in relation to such a duty.

- (1) A member of the Senate who has a material personal interest in a matter being considered or about to be considered by the Senate must, as soon as possible after the relevant facts have come to the member's knowledge, disclose the nature and extent of the interest at a meeting of the Senate.
- (2) A disclosure under subclause (1) is to be recorded in the minutes of the meeting.

3. Voting by interested members

A member of the Senate who has a material personal interest in a matter that is being considered by the Senate —

- (a) must not vote whether at a meeting or otherwise
 - (i) on the matter; or

and

- (b) must not be present while
 - (i) the matter; or
 - (ii) a proposed resolution of the kind referred to in paragraph (a)(ii),

is being considered at a meeting.

Clause 3 does not apply if the Senate has at any time passed a resolution that —




Effect of approval to lease University land To the extent that an approval authorises the University to lease University land, land leased in accordance with the approval is to be taken to be used for the purposes of the University or for purposes incidental to the purposes of the University for the purposes of compliance with any conditions, restrictions or limitations (however arising) attaching to the vesting of that land in the University or the holding, care, control or management, by the University, of that land; and any provision of any written law that specifies that something is to happen or not to happen, or provides for some other consequence, if that land is not used, or ceases to be used, for the purposes of the University or for purposes incidental to the purposes of the University. The Land Tax Assessment Act 2002 section 33 overrides this section. Approval in principle of university development proposal (1) The University may apply to the Minister for the approval in principle of a university development proposal. The university development proposal submitted for approval in principle must describe what the University intends to seek an approval under section 32M for, including (a) details of the University land that is to be leased; and (b) the purpose for which the land is to be leased.
