# INDUSTRIAL AND COMMERCIAL EMPLOYEES' HOUSING ACT 1973

### Industrial and Commercial Employees' Housing Regulations 1974

His Excellency the Governor in Executive Council, acting pursuant to section 10 of the *Industrial and Commercial Employees' Housing Act 1973*, and section 11 of the *Interpretation Act 1918-1972* has been pleased to make the regulations set out in the Schedule hereto.

#### 1. Citation and commencement

These regulations may be cited as the *Industrial and Commercial Employees' Housing Regulations 1974*, and shall come into operation on the day on which the Act comes into operation.

#### 2. Interpretation

In these regulations — "**the Act**" means the *Industrial and Commercial Employees*' *Housing Act 1973*.

#### **3.** Fees for attendance at meetings

The following fees for attendance at meetings are prescribed for the purposes of section 10 (2) of the Act —

- (a) Chairman ..... \$96 for a full day meeting.\$64 for a half day meeting.
- (b) Other members . . . . \$72 for a full day meeting.\$48 for a half day meeting.
