1. Citation

These regulations are the Western Australian Health Promotion Foundation Regulations 2016.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day on which the *Western Australian Health Promotion Foundation Act 2016* Part 6 comes into operation.

3. Foundation's Funds

For the purposes of section 43(2) of the Act, the amount specified in Column 2 of the Table opposite a financial year specified in Column 1 is the prescribed amount for that financial year.
