1. Citation

These regulations may be cited as the *Petroleum (Submerged Lands) Registration Fees Regulations 1990*⁺.

2. Commencement

These regulations shall come into operation on the commencement of the *Petroleum (Submerged Lands) Registration Fees Amendment Act 1990*⁺.

3. Amounts prescribed (Act s. 4)

- (4) For the purposes for section 4(6) of the Act, the prescribed amount is an amount of \$~~5-724~~6 010.00.

- (5) For the purposes of section 4(7) of the Act, the prescribed amount is an amount of \$~~8-7079~~ 140.00.
