Abrolhos Islands Fishery means the Fishery as defined in the Abrolhos Islands Notice clause 2;

Abrolhos Islands Notice means the Abrolhos Islands and Mid West Trawl Managed Fishery Voluntary Fisheries Adjustment Scheme Notice 2009 as amended by the Abrolhos Islands and Mid West Trawl Managed Fishery Voluntary Fisheries Adjustment Scheme Amendment Notice 2010 and the Abrolhos Islands and Mid West Trawl Managed Fishery Voluntary Fisheries Adjustment Scheme Amendment Notice 2015;

Abrolhos Islands Voluntary Scheme means the voluntary fisheries adjustment scheme established by the Abrolhos Islands Notice clause 3;

authorisation means an authorisation that authorises fishing in the Abrolhos Islands Fishery.
