# **State Enterprises (Commonwealth Tax Equivalents) (Application) Regulations 1997**

### 1. Citation

These regulations may be cited as the *State Enterprises* (*Commonwealth Tax Equivalents*) (*Application*) Regulations 1997<sup>1</sup>.

### 2. Commencement

These regulations come into operation on the day on which the *State Enterprises (Commonwealth Tax Equivalents) Act 1996* comes into operation <sup>1</sup>.

# **3.** State enterprises prescribed (section 5)

The State enterprises set out in column 1 of the Table are prescribed for the purposes of section 5 of the Act, commencing on and from the date set out opposite in column 2 of that Table.
