## Mutual Recognition (Western Australia) (Temporary Exemption) Regulations 2021

### 1. Citation

These regulations are the *Mutual Recognition (Western Australia) (Temporary Exemption) Regulations 2021*.

### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 July 2022.

### 3. Temporary exemption: law relating to prohibited plastics (s. 5)

[\(1\)](#) The *Environmental Protection (Prohibited Plastics and Balloons) Regulations 2018* Parts 2 and 3 are declared to be a law to which section 15 of the Commonwealth Act applies.

[\(2\)](#) [Subregulation \(1\) applies to the \*Environmental Protection \(Prohibited Plastics and Balloons\) Regulations 2018\* Parts 2 and 3 only to the extent that those provisions relate to items that fall within the meaning of “prescribed drinking straw”, “prescribed plastic bag” or “prescribed plastic item”, as those terms were defined in those regulations as in force on 28 February 2023.](#)
