Petroleum and Geothermal Energy Resources (Registration Fees) Regulations 1990

1. Citation

These regulations may be cited as the *Petroleum and Geothermal Energy Resources (Registration Fees) Regulations 1990*.

2. Commencement

These regulations shall come into operation on the commencement of the *Petroleum (Registration Fees) Amendment Act 1990*.

3. Prescribed amounts

- (1) For the purposes of section 4(2) of the Act, the prescribed amount is an amount of \$6 010.00.
- (2) For the purposes of section 4(3) of the Act, the prescribed amount is an amount of \$6 010.00.
- (3) For the purposes of section 4(4) of the Act, the prescribed amount is an amount of \$9 550.00.
- (4) For the purposes of section 4(6) of the Act, the prescribed amount is an amount of \$6 010.00.

- (5) For the purposes of section 4(7) of the Act, the prescribed amount is an amount of \$9 140.00.
