# **Limited Partnerships Rules 1909**

### 1. Citation

These rules may be cited as the *Limited Partnerships Rules* 1909 <sup>1</sup>.

## 1A. Interpretation

In these rules, "the Act" means the Limited Partnerships Act 1909.

# 2. The Registrar of Companies

Whenever any act is by the Act directed to be done to or by the Registrar <sup>2</sup> such act shall be done to or by the Registrar of Companies or in his absence to or by such person as the Attorney General may for the time being authorise.

### 3. Fees

The fees to be paid to the Registrar under the Act shall be as follows:

- (a) On the original registration of a limited partnership the sum of \$142154.
- [(b) deleted]

- (c) By any person inspecting the statements filed by the Registrar in the Register Office the sum of \$4 for each inspection.
- (d) By any person requiring a Certificate of the registration of any limited partnership or a certified copy of or extract from any registered statement the sum of \$910.50 for each certificate and for such certified copy or extract the sum of \$4 for each folio of 72 words.

### 4. Forms

A statement (Form L.P. 4) of any increase in the amount of the partnership capital, whether arising from an increase of contributions, or from introduction of fresh partners, must be made on a separate form, for the purpose of payment of capital duty, pursuant to Section 11 of the Act.
