## **Evidence (Examination of witnesses outside the State) Regulations 1991**

### **1. Citation**

These regulations may be cited as the *Evidence (Examination of witnesses outside the State) Regulations 1991*<sup>1</sup>.

### **2. Commencement**

These regulations shall come into operation on the day on which section 9 of the *Evidence Amendment Act 1987* comes into operation<sup>1</sup>.

### **3. Judicial authorities prescribed for Act s. 109**

Under section 109 of the Act, the courts or persons in Column 2 of the Table to this regulation are prescribed as appropriate judicial authorities for the place beside them in Column 1 of the Table.
