## ALBANY HARBOUR BOARD.

No. 4 of 1967.

## AN ACT to amend the Albany Harbour Board Act. 1926-1965.

[Assented to 5th October, 1967.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent the Legislative Council and the Legislative of Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:----

(1) This Act may be cited as the Albany Short title and citation. 1. Harbour Board Act Amendment Act, 1967.

(2) In this Act the Albany Harbour Board Act, Act No. 52 1926-1965, is referred to as the principal Act.

(3) The principal Act as amended by this Act 52 of 1955. may be cited as the Albany Port Authority Act, 9 of 1963 10 of 1965 and 1926 - 1967.

Commencement. 2. This Act shall come into operation on a date to be fixed by proclamation.

AN ACT to constitute the ALBANY PORT AUTHORITY; to regulate the appointment of the members of the ALBANY PORT AUTHORITY; to define its powers and authorities; and for other purposes incidental thereto.
