RESERVES.

No. 66 of 1967.

AN ACT relating to certain Reserves and other Lands.

[Assented to 5th December, 1967.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:-

- 1. This Act may be cited as the Reserves Act, 1967. Short title.
- 2. (1) Reserve No. 6862, near Albany, classified Reserve No. as of Class "A", set apart for the "Protection of Albany. Boronia" and vested in the National Parks Board of Western Australia, is hereby amended by excising portion of Albany Lot 1180 containing two acres one rood thirty-eight perches, more or less, as shown on Lands and Surveys Original Plan No. 10269.

(2) The land excised by the operation of subsection (1) of this section shall be included in Reserve No. 22698 set apart for the purpose of "Residence and Business Areas and Public Utility".

AlbanyLots 312 and 315. 3. The Trustees of the Public Education Endowment may sell the land comprised in Albany Lots 312 and 315 being the balance of land in Certificate of Title 970 Folio 94, freed and discharged of all trusts, subject to the proceeds of the sale being invested in accordance with the provisions of the Public Education Endowment Act, 1909.

Reserve No. 24364 at Binningup Beach.

- 4. (1) Reserve No. 24364, at Binningup Beach, classified as of Class "A", set apart for the purpose of "Water Supply" and vested in the Shire of Harvey, is hereby amended by excising an area of seventeen and nine-tenths perches more or less, being a strip of land between Lot 95 and Lot 96 on Land Titles Office Plan No. 6522.
- (2) The land excised by the operation of subsection (1) of this section shall be made available for exchange purposes under section eight of the Land Act, 1933, in such manner as the Governor may approve.

Reserve No. 8519 at Broome. 5. Reserve No. 8519 comprising Broome Lots 135, 138, 139, 140, 141, 142 and 472 and containing four acres and thirty-two perches classified as of Class "A" and set apart for the purpose of "Recreation" is hereby reclassified as of Class "C" with the intention that the Governor may set apart separate reserves or otherwise dispose of any portion in accordance with the provisions of the Land Act, 1933.

Reserve No. 22674 near Busselton. 6. (1) Reserve No. 22674, classified as of Class "A" and set apart for the purpose of "Camping and Recreation" is hereby amended by the excision of an

area of one rood twenty-seven and three-tenths perches, as surveyed and shown on Lands and Surveys Diagram No. 71990.

- (2) The land excised by the operation of subsection (1) of this section shall be added to the contiguous Drain Reserve.
- 7. (1) Reserve No. 11379, classified as of Class "A" Reserve No. and set apart for the purpose of a Public Education Colle. Endowment, is hereby amended by the excision of Collie Lot 973 containing an area of one rood, being portion of the land comprised in Certificate of Title Volume 567 Folio 46.

- (2) The Trustees of the Public Education Endowment may sell the land excised by the operation of subsection (1) of this section, freed and discharged of all trusts, subject to the proceeds of the sale being invested in accordance with the provisions of the Public Education Endowment Act, 1909.
- 8. (1) Reserve No. 1203, at Cottesloe, classified as Reserve No. 1203 at of Class "A", set apart for the purpose of "Recreation" and vested in the Town of Cottesloe, is hereby amended by excising an area of five perches, more or less, to be surveyed as Cottesloe Lot 341.

- (2) The land excised by the operation of subsection (1) of this section may be made available to the North Cottesloe Surf Life Saving Club Incorporated, in such manner as the Governor may approve, under the provisions of the Land Act, 1933.
- 9. (1) Reserve No. 20195, being Geraldton Lot Reserve No. 1142, containing approximately sixty-one acres two Geraldton. roods and twenty-two perches, classified as of Class "A" and set apart for the purposes of "Park and Recreation" and vested in the Town of Geraldton, in trust for those purposes, is hereby amended by excising an area of three roods ten perches and being

now part of Geraldton Lot 2332 as surveyed and shown on Lands and Surveys Diagram No. 72336.

(2) The land excised by the operation of subsection (1) of this section shall be included in the contiguous Reserve No. 27530 set apart for the purpose of "Caravan Park".

Reserve **No.** 12083 at South Kalamunda.

- 10. (1) That portion of Reserve No. 12083, at South Kalamunda, classified as of Class "A" and set apart for the purpose of a Public Education Endowment and held in fee simple by the Trustees of the Public Education Endowment, under Certificate of Title Volume 1317 Folio 161, is hereby amended by excising Lot 1 of Kalamunda Lot 111 containing one acre two roods thirty-seven and six-tenths perches, surveyed and shown on Lands and Surveys Diagram No. 72379.
- (2) The Trustees of the Public Education Endowment may sell the land excised by the operation of subsection (1) of this section to the State Electricity Commission of Western Australia, freed and discharged of all trusts, subject to the proceeds of the sale being invested in accordance with the provisions of the Public Education Endowment Act, 1909.

Reserve No. 2077 at Mosman Park.

- 11. (1) Reserve No. 2077 at Mosman Park, classified as of Class "A" and set apart for the purpose of "Recreation" and vested in the Town of Mosman Park, in trust, for that purpose, under the provisions of section thirty-three of the Land Act, 1933, is hereby reclassified as of Class "C".
- (2) The purpose of Reserve No. 2077 is hereby changed from "Recreation" to "Housing".

Reserve No. 1759 at Nunijup (near Tenterden). 12. (1) Reserve No. 1759, containing approximately 262 acres, classified as of Class "A" and set apart for the purpose of "Water", and under the

control of the Shire of Cranbrook, is hereby amended by excising an area of thirty-nine acres one rood nine perches comprising Hay Location 2284 as shown on Lands and Surveys Diagram No. 72365.

- (2) The land excised by the operation of subsection (1) of this section shall be reserved for the purpose of "Recreation".
- 13. (1) Reserve No. 22240, in Perth, containing Reserve No. 22240 Perth. four acres two roods and thirty-two perches. classified as of Class "A" and set apart for the purpose of "Public Buildings", is hereby amended by excising an area of two roods twenty-five and four-tenths perches, more or less, to be surveyed as Perth Town Lot 842.

- (2) The land excised by the operation of subsection (1) of this section shall be reserved for the purpose of a "Concert Hall and Associated Uses" in such manner as the Governor may approve, under the provisions of the Land Act, 1933.
- 14. (1) Reserve No. 3412, at Powlalup, classified Reserves Nos. 3412 and 25412 and 254 and 254 Powlal as of Class "A" and set apart for the purpose of "Resting Place for Travellers and Stock", is hereby amended by the excision of all that portion containing approximately eight acres, subject to survey, as coloured violet on Lands and Surveys Miscellaneous Plan 403.

- (2) Reserve No. 25446, at Powlalup, classified as of Class "A" and set apart for the purpose of "Conservation of Flora and Fauna" and vested in The Fauna Protection Advisory Committee of Western Australia, is hereby amended by the excision of those portions containing in the aggregate approximately fifty-five acres, subject to survey, as coloured green on Lands and Surveys Miscellaneous Plan 403.
- (3) The lands excised by the operation of subsections (1) and (2) of this section may be made available for forestry purposes in such manner as the Governor may approve.

Reserve No. 15962 at Quairading.

- 15. (1) Reserve No. 15962 classified as of Class "A" and set apart for the purpose of "Park Lands and Recreation" is hereby amended by the excision of an area of one rood two and nine-tenths perches, now surveyed as Quairading Lot 298.
- (2) The land excised by the operation of subsection (1) of this section shall be reserved for the purpose of a "Fire Station".

Reserve No. 11290 at Rocky Gully.

- 16. (1) Reserve No. 11290 classified as of Class "A", set apart for the purpose of "Camping Ground and Resting Place for Travellers and Conservation of Indigenous Timber and Flora" and vested in the Shire of Plantagenet, is hereby amended by the excision of five acres one rood thirteen perches as shown on Lands and Surveys Diagram No. 72375.
- (2) The portion of land designated Hay Location 2285 and containing five acres excised by the operation of subsection (1) of this section shall be set apart as a reserve for the purpose of a "Cemetery Site".
- (3) The portion of land shown coloured dark brown on Lands and Surveys Diagram No. 72375 and containing one rood thirteen perches excised by the operation of subsection (1) of this section shall be provided for access purposes.

Reserve No. 12071 at Roebourne.

- 17. (1) Reserve No. 12071, at Roebourne, classified as of Class "A" and set apart for the purpose of Educational Endowment, is hereby amended by the excision of Roebourne Lots 278 to 289, inclusive, containing an area of six acres, being portion of the land comprised in Certificate of Title Volume 570 Folio 65.
- (2) The land excised by the operation of subsection (1) of this section is hereby revested in Her Majesty as of her former estate and is removed from the operation of the Transfer of Land Act, 1893.

- (3) The land revested by the operation of subsection (2) of this section shall be set apart, together with other contiguous land, as a reserve for the purpose of "Effluent Disposal".
- 18. (1) Reserves 3355, 8615, 8650, 8651, 20357, Reserves at Serpentine. 21904 and 23894 each classified as of Class "A" are hereby cancelled.

- (2) The reserves cancelled by the operation of subsection (1) of this section are hereby amalgamated into one composite reserve, classified as of Class "A" and set apart as Reserve No. 28862 for the purpose of "National Park".
- (3) The Governor is authorised to vest Reserve No. 28862 in the National Parks Board of Western Australia, in trust, for the purpose of "National Park".
- 19. (1) Reserve No. 9868, at Yanchep, containing Reserve No. 9868 at six thousand two hundred and ninety-one acres Yanchep. three roods twenty-three perches, classified as of Class "A" and set apart for the purposes of "Protection and Preservation of Caves and Flora, and for Health and Pleasure Resort", is hereby amended by excising Swan Location 8240 containing thirtyseven acres, more or less, subject to survey.

(2) The land excised by the operation of subsection (1) of this section shall be reserved under the provisions of the Land Act, 1933, for the purpose of "Forestry Headquarters Site", and shall be vested in the Conservator of Forests, in trust, for that purpose.
