## AN ACT to amend the Fremantle Harbour Trust Act, 1902-1960.

[Assented to 12th November, 1964.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and citation.

(1) This Act may be cited as the Fremantle Harbour Trust Act Amendment Act, 1964.

- (2) In this Act the Fremantle Harbour Trust Act, 1902-1960, is referred to as the principal Act.
- (3) The principal Act as amended by this Act may be cited as the Fremantle Port Authority Act. 1902-1964.

- 2. This Act shall come into operation on a date Commencement. to be fixed by proclamation.
- 3. The long title of the principal Act is Long title amended. amended—
  - (a) by substituting for the words, "Fremantle Harbour Trust Commission" in lines one and two, the words, "Fremantle Port Authority"; and
  - (b) by substituting for the words, "their powers and authorities" in lines three and four, the words, "the powers and authorities of the Fremantle Port Authority".

- (2) A reference to the Fremantle Harbour Trust Commissioners, whether by use of that name or a similar or abbreviated form of that name,—
  - (a) in a law of the State passed or made before the commencement of section:
  - (b) in any document or other instrument made, executed, entered into or done before the commencement of this section: and

(c) made before the commencement of this section in any other manner,

shall, unless the context is such that it would be incorrect or inappropriate, be read and construed as a reference to the Fremantle Port Authority.

- (3) For the purposes of this section the term "law of the State" means-
  - (a) an Act;
  - (b) regulations, rules or by-laws having effect by virtue of an Act; and
  - (c) an instrument having effect by virtue of an Act or of any regulations, rules or by-laws referred to in paragraph (b) of this subsection. .
