# AN ACT to revise the Statute Law by repealing spent, unnecessary or superseded enactments.

[Assented to 4th December, 1964.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Statute Law Revision Act, 1964.

Repeal. 2. The enactments specified in the First Schedule are hereby repealed.

Repeal. 3. (1) The enactments specified in the Second Schedule are hereby repealed.

Short title.

1964.] Statute Law Revision.

(2) For the purposes of sections ninety-six, ninety-seven and ninety-nine of the Public Works Act, 1902-1961—

- (a) the railway made under the authority of any enactment repealed by this section continues to be a railway authorised by a special Act; and
- (b) any limits of deviation authorised by that repealed enactment continue to be the authorised limits of deviation of that railway.

4. It is declared that each enactment specified <sup>Repeal.</sup> in the first column of the Third Schedule was repealed on the date and by the enactment specified opposite to it in the second and third columns respectively of that schedule.

5. It is declared that the enactments specified in Repeal. the Fourth Schedule were repealed on 8th August, 1913.

6. Each enactment specified in the Fifth Schedule Repeal. is deemed not to have been passed by the Parliament of Western Australia.
