Where estate does not exceed £2,500 the Master or district agent may act. 55. In all cases where a person dies leaving property not exceeding two thousand five hundred pounds in value, application for probate or administration may be made direct to the Master; or if the fixed abode of the deceased at the time of his death has been more than fifty miles from Perth, then to the district agent for the Master nearest to such place of abode.
