AN ACT to amend the Government Employees (Promotions Appeal Board) Act, 1945-1956.

[Assented to 2nd December, 1960.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:-

1. (1) This Act may be cited as the Government short title Employees (Promotions Appeal Board) Act Amendment Act, 1960.

- (2) In this Act the Government Employees Reprinted in (Promotions Appeal Board) Act, 1945-1956, is Reprinted referred to as the principal Act.
- (3) The principal Act as amended by this Act may 11th June, 1956, and be cited as the Government Employees (Promotions further amended by Appeal Board) Act, 1945-1960.

Commencement.

2. This Act shall come into operation on a day to be fixed by proclamation.

## S. 3 amended.

- 3. Section three of the principal Act is amended—
  - (a) by adding after the word, "department" in line one of the interpretation "Department", the passage, ", except the Education Department,";
  - (b) by adding after the passage, "department," in line three of the interpretation "Employee", the passage "except the Education Department,".

## S. 5 amended.

- 4. Section five of the principal Act is amended—
  - (a) by deleting the passage, ", which is not that of a teacher in any Government school as defined in section three of the Education Act, 1928, or in any teachers' training college established or maintained under that Act, but" in line two of subparagraph (i) of paragraph (a) of the proviso to subsection (1);
  - (b) by deleting the word, "or" in line four of subparagraph (ii) of paragraph (a) of the proviso to subsection (1); and
  - (c) by repealing subparagraphs (iii) and (iv) of paragraph (a) of the proviso to subsection (1) and the word, "or" between those subparagraphs.

- 5. Section six of the principal Act is amended—
  - (a) by deleting the passage, "the State School Teachers' Union of W.A., Incorporated," in lines six, seven and eight of subparagraph (ii) of paragraph (c) of subsection (2); and
  - (b) by repealing paragraph (b) of subsection (3).
