Effect of

Acts.

The principal Act is amended by adding after 3. section eight the following section-

8A. Employment or appointment of a person, or use being made of a person's services by the Protection Board, whether before, on or after the day of the coming into operation of the Agriculture Protection Board Act Amendment Act, 1956, does not of itself render the provisions of the Public Service Act, 1904; the Public Service Appeal Board Act, 1920; the Govern-ment Employees (Promotions Appeal Board) Act, 1945; or the Superannuation and Family Benefits Act, 1938; applicable to him if not applicable to him at the time of his being so employed or appointed, or use being so made of his services, nor affect the application to him of those provisions if applicable to him at the time of his being so employed or appointed, or use being so made of his services.
