# AN ACT to Authorise the Discontinuance of the Belmont Branch Railway and to Revest in Her Majesty the land comprised in that Railway.

 $B^{E}$  it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the 

1. This Act may be cited as the Belmont Branch short title and citation. Railway Discontinuance and Land Revestment Act, 1956.

2. In this Act—

"prescribed railway" means the railway described in the First Schedule to this Act.

Interpretation.

#### No. 34.] Belmont Branch Railway Discontinuance and Land Revestment.

Discontinuance of railway.

3. The prescribed railway shall cease to be operated on and from the coming into operation of this Act.

Authority to re-use or dispose of material.

Vol. 7 of the Reprinted Acts.

(1) The Minister is authorised to direct that 4. the material comprising the prescribed railway-

- (a) be used in the maintenance of any Government Railway according to the meaning given to that expression by section two of the Government Railways Act, 1902;
- (b) be used in the construction of any railway authorised, under section ninety-five of the Public Works Act, 1902, to be constructed, whether before or after the coming into operation of this Act, for Her Majesty in the State: or

(c) be sold, disposed of, or otherwise dealt with.

(2) A direction issued under this section by the Minister has, and shall be given, effect according to its tenor.

5. The cost of the prescribed railway, as charged Authority to to the Government Railways Capital Account, may be omitted from the accounts prepared under Part IV. of the Government Railways Act, 1902.

Revesting of The land described in the Second Schedule 6. to this Act, being the land comprised in the prescribed railway, is hereby Her revested in Majesty as of her former estate.

## FIRST SCHEDULE.

## Description of Railway.

All that railway commencing at a point approximately 4 miles 20 chains 42 links from Perth between Slade and Cobden Streets in Bayswater and proceeding generally in a southerly direction for a distance of 2 miles 7 chains 7 links or thereabouts to the northern boundary of Hardeys Road, Belmont, adjacent to Location 31. The line was officially opened for traffic on 1st January, 1895.
