AN ACT to amend the Police Act, 1892-1945, and, where necessary for the purpose of reprinting, to revise certain of the Acts amending "The Police Act, 1892" (Act 55 Victoriæ No. 27).

[Assented to 7th November, 1952.]

**B**<sup>E</sup> it enacted, by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

- 1. This Act may be cited as the *Police Act* Short title. Amendment Act, 1952.
- 2. This Act shall come into operation on a day commence-to be fixed by proclamation.
- 3. In this Act, unless the context requires tation. otherwise—

"principal Act" means the Police Act, 1892-1945, being Act 55 Victoriæ No. 27 as reprinted in The Statutes of Western Australia Volume II, 1883-1892, By Authority 1896, and amended by the amending Acts.

- 4. The principal Act as amended by this Act may be cited as the Police Act, 1892-1952.
