AN ACT to amend the Noxious Weeds Act, 1950.

[Assented to 12th October, 1951.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:----

This Act may be cited as the Noxious Weeds short utle. 1. Act Amendment Act, 1951, and shall be read as one with the Noxious Weeds Act, 1950 (Act No. 60 of 1950) referred to in this Act as the principal Act.

The principal Act, as amended by this Act, may citation of principal 2. be cited as the Noxious Weeds Act, 1950-1951.

(3a) The Protection Board may, in the same manner and to the same extent as is provided in the last preceding subsection for the delegation by the Minister of all or any of his powers and functions under or by virtue of this Act, delegate to the Chief Weed Control Officer all or any of its powers and functions exercisable under or by virtue of this Act and the provisions of the last preceding subsection shall apply in respect of the powers and functions of the Protection 1951.]

Board and the delegation to and the exercise by the Chief Weed Control Officer of any of those powers and functions as if those provisions were repeated at length *mutatis mutandis* in this subsection.
