AN ACT to amend the Railways Classification Board Act, 1920-1935.

[Assented to 9th January, 1946.]

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:---

1. This Act may be cited as the *Railways Classifica*tion Board Act Amendment Act, 1945, and shall be read as one with the Railways Classification Board Act, 1920-1935 (No. 38 of 1920 as amended by the Act No. 33 of 1935), hereinafter referred to as the principal Act.

2. Section three of the principal Act is amended by deleting from subsection (2) the words "Railway and Tramway Officers' Industrial Union of Workers" whereever they appear in the said subsection and inserting in lieu thereof in every such case the words "W.A. Railway Officers' Union."

Amendment of s. 6. 3. Section six of the principal Act is amended by deleting the words "Railway and Tramway Officers' Industrial Union of Workers" in lines three and four of the said section and inserting in lieu thereof the words "W.A. Railway Officers' Union."

Amendment of s. 7. 4. Section seven of the principal Act is amended by deleting the words "Railway and Tramway Officers' Industrial Union of Workers" in lines six and seven of

subsection (2) of the said section and inserting in lieu thereof the words "W.A. Railway Officers' Union."

Section nine of the principal Act is amended by Amendment 5. deleting from paragraph (b) the words "Railway and Tramway Officers' Industrial Union of Workers'' in lines four and five of the said paragraph (b) and inserting in lieu thereof the words "W.A. Railway Officers' Union."

Section twenty-two B of the principal Act is Amendment 6. amended by deleting the words "Railways and Tramway Officers' Industrial Union of Workers'' in lines two and three of the said section and inserting in lieu thereof the words "W.A. Railway Officers' Union."

A section is added to the principal Act after section New section. 7. twenty-five as follows:----

26. Notwithstanding anything to the contrary Recovery by W.A. Railway contained in the Trade Unions Act, 1902, and while Officers' Union the W.A. Railway Officers' Union continues to be devices and empowered to elect persons to be members of the Board under this Act, all fines, fees, levies and dues payable under the rules of the said W.A. Railway Officers' Union by the members thereof may, insofar as they may become owing to the said Union after the commencement of this section, be sued for and recovered in a Local Court or other Court of summary jurisdiction.

8. The title of the principal Act is amended by adding Amendment of title of the thereto the words "and to make provision for the re-principal Act. covery by the W.A. Railway Officers' Union of fines, fees, levies and dues owing by the members thereof."
