

## RESERVES.

3° GEO. VI., No. IV.

### No. 4 of 1939.

#### AN ACT relating to certain Reserves and other land.

[Assented to 5th October, 1939.]

**BE** it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Reserves Act* (No. 1), 1939. Short title.

2. All those portions of reserves numbered respectively "A"13012, "A"12510, "A"13375, "A"17826 and "A"17615 in the city of Perth, more particularly described in the First Schedule to this Act, are hereby excised from the said reserves to the intent that they shall be dedicated as public roads under the provisions of the Municipal Corporations Act, 1906-1938, as "Riverside drive," "Terrace road," and extensions of Plain street, Bennett street, and Hill street respectively.

3. All that portion of reserve "A"7691, for national park, in the Nelson district, more particularly described

in the Second Schedule to this Act, is hereby excised from the said reserve to the intent that it shall be included in the State forest adjoining the same.

4. All that piece of land, being Cottesloe lot 182, held for an estate in fee simple by the Western Australian Fire Brigades Board in trust for the purpose of a fire station site, may be sold and transferred by the said board for such consideration as the said board as vendor may think fit, and the said land, when so transferred, shall be freed and discharged from the trust aforesaid.

5. Notwithstanding the provisions of section three of the Swanbourne Reserve Act, 1931, that piece of land, formerly portion of reserve "A" 7804, more particularly described in Part II. of the Schedule to the said Swanbourne Reserve Act, 1931, shall be deemed to be Crown land within the meaning and for the purposes of the Land Act, 1933-1938, and as such may be disposed of under and in accordance with the provisions of the said last-mentioned Act.

6. All that portion of reserve "A" 18987, for national park (Porongorup Range), surveyed and shown as Plantagenet location 5615 on diagram 57394 in the Department of Lands and Surveys, is hereby excised from the said reserve and may be dealt with under the provisions of the Land Act, 1933-1938, as the Governor may think fit.

7. All that piece of land, being reserve 15738, known as Avon location 20059, at present held under a nine hundred and ninety-nine years lease by Robert Pollock, William Chambers Hunter, and Thomas James Teasdale, in trust for an agricultural hall and recreation ground, is hereby revested in His Majesty as of his former estate, to the intent that the said land shall be again set aside and reserved as an agricultural hall site and recreation ground and be vested in, granted or leased under the provisions of section thirty-three of the Land Act, 1933-1938, to Bruce Rock Road Board, or to such other body or persons as the Governor may approve for the said purposes.

8. All that reserve "A" 18956, for park lands and recreation, vested in Bayswater Road Board under section forty-two of the Land Act, 1898, is hereby cancelled, to the intent that the land comprised in the said reserve shall be declared to be a public road under the provisions of the Road Districts Act, 1919-1937, as an addition to Beaufort street.

9. All that portion of reserve "A" 3617, for recreation purposes, vested in South Perth Road Board, and more particularly described in the Third Schedule to this Act, is hereby excised from the said reserve, to the intent that it shall be set apart as a reserve for an infant health clinic.

10. All that portion of reserve "A" 17863, vested in the Melville Road Board for recreation purposes, surveyed and shown on diagram 60568 in the Department of Lands and Surveys, as Cockburn Sound location 873, and containing 34 3/10ths perches, is hereby excised from the said reserve, to the intent that it shall be set apart as a reserve for an infant health clinic.

11. All that piece of land, being Kalgoorlie lot 2810, the subject of a nine hundred and ninety-nine years lease, granted to Fritz Hamann, Mark Storen, and Charles Cocking, as trustees for the Eastern Goldfields Brewery Employees' Union of Workers, as a site for a hall is hereby revested in His Majesty the King as of his former estate, to the intent that it be again set apart and reserved as a site for a hall and that a similar lease of the said land may be granted to the trustees for the time being of the Eastern Goldfields Brewery Employees' Industrial Union of Workers.

12. All those pieces of land, being Katanning town lots 525, 526, and 527, and being portion of reserve "A" 12076, granted to the Trustees of the Public Education Endowment of Western Australia in trust for the endowment of public education, are hereby excluded from the said reserve; and the said trustees are hereby authorised and empowered to surrender the said lots to His Majesty the King to the intent that the said lots shall be revested in His said Majesty as of his former estate and

be set apart for railway purposes or for such other purposes as the Governor may think fit under the provisions of Part III. of the Land Act, 1933-1938.

#### FIRST SCHEDULE.

1. All those portions of reserves "A"13012, "A"12510, "A"13375 and "A"17826, coloured brown and shown as Riverside drive on original plan No. 5268 in the Department of Lands and Surveys.
2. All that portion of reserve "A"12510, delineated, coloured brown and shown as an extension of Plain street on original plan No. 5268 in the Department of Lands and Surveys.
3. All that portion of reserve No. "A"12510, delineated, coloured brown and shown as an extension of Bennett street on original plan No. 5268 in the Department of Lands and Surveys.
4. All that portion of reserve "A"12510, delineated, coloured brown and shown as an extension of Hill street on original plan No. 5268 in the Department of Lands and Surveys.
5. All that portion of reserve "A"17615, delineated, coloured brown and shown as part of Riverside drive on original plan No. 5269 in the Department of Lands and Surveys.
6. All those portions of reserves "A"12510 and "A"13375, delineated, coloured brown and shown as Terrace road on original plan No. 5268 in the Department of Lands and Surveys.

#### SECOND SCHEDULE.

The area bounded by lines starting from the present north-west corner of the reserve and extending south along part of its west boundary for a distance of 17 chains 50 links; thence about 106 degrees 45 minutes 92 chains; thence about 84 degrees 30 minutes 53 chains to the western side of a surveyed road on the west boundaries of locations 473 and 2321; thence northward along said side of road to the present north boundary of the reserve and thence west to the starting point.

#### THIRD SCHEDULE.

All that portion of class "A" reserve 3617 and being portion of Perth suburban lot 425 bounded on the southward and eastward by lines starting from the intersection of the west side of Coode street with the northern side of Hensman street and extending westward along Hensman street for a distance of 100 feet and northward along Coode street for a distance of 75 feet, and by opposite boundaries parallel and equal.
