AN ACT for the closure of certain roads and of portions of certain roads; and for other purposes.

[Assented to 16th December, 1939.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

- 1. This Act may be cited as the Road Closure Act, 1939.
- Closure of portions of Unicorn street in Wagin.
- 2. All those portions of Unicorn street, in the municipal district of Wagin, being—
 - (a) that portion lying between the production southwestward of the south-eastern side of Tasman street and the production south-westward of the north-western side of Thornton street; and
- (b) that portion lying between the production southwestward of the south-eastern side of Thornton street and the northern side of Arthur road are hereby closed, and all rights-of-way over the same shall cease on the passing of this Act.

All that portion of a street, which is not named, closure of portion of in the Mt. Hawthorn locality of the city of Perth, more street not the particularly described in the First Schedule to this Act, Mt. Hawthorn locality of is hereby closed; all rights-of-way over the same shall the city of Perth. cease on the passing of this Act, and the land comprised therein is hereby revested in His Majesty the King as of his former estate.

All that portion of Howick street, in the municipal Closure of district of York, lying between the southern alignment Howick of Pool street and the northern alignment of Macartney York. street, is hereby closed, and all rights-of-way over the same shall cease on the passing of this Act.

All that portion of Evans street, in the municipal Closure of district of Geraldton, lying between the southern alignment of Augustus street and the northern alignment of Shenton street, is hereby closed, and all rights-of-way over the same shall cease on the passing of this Act.

All that portion of Woodman street, in the municipal district of Kalgoorlie, more particularly described woodman in the Second Schedule to this Act, is hereby closed, and Kalgoorlie. all rights-of-way over the same shall cease on the passing of this Act.

7. All those portions of the roads hereinafter men- closure of tioned, situate in the municipal district of Wagin, that portions of certain roads is to say-

- (a) that portion of Hamersley road from the southern alignment of a road at the north-eastern corner of Wagin lot 826 to the northern alignment of Taylor road; and
- (b) that portion of Cowcher road from Hamersley road to Barron road; and
- (c) that portion of Spratt road from Hamersley road to Barron road-

are all, and each and every one of them, hereby closed, and all rights-of-way over the said portions of the said roads shall cease on the passing of this Act.

All those portions of Pembroke street, in the City Closure of of Perth, from the eastern alignment of Shakespeare Pembroke street to the western alignment of T street to the western alignment of Dunedin street, and city of Perth.

from the eastern alignment of Dunedin street to the western alignment of London street, are hereby closed, all rights-of-way over the same shall cease on the passing of this Act, and the estate in fee simple of the land comprised in the portions of the said street so closed is hereby transferred to the city of Perth, and the Registrar of Titles is hereby authorised and directed to register such transfer accordingly.

FIRST SCHEDULE.

All that portion of Swan location 669 bounded by lines starting from the south-eastern corner of subdivisional lot 290 of aforesaid location as shown on L.T.O. plan 3642 and extending southerly 60 5/10 links to the north-eastern corner of lot 292; thence westerly 1 chain 92 1/10 links along part of the northern boundary of the latter lot; thence northerly 60 5/10 links to a point on the southern boundary of the said lot 290; and thence easterly 1 chain 92 1/10 links along the latter boundary to the starting point.

SECOND SCHEDULE.

All that portion of Woodman street bounded by lines starting from the south corner of Kalgoorlie town lot 2066 and extending 313 degrees 30 minutes 4 chains 90 links; thence 358 degrees 30 minutes 42 4/10 links to the south-eastern alignment of Piccadilly street; thence 223 degrees 30 minutes 1 chain; thence 178 degrees 30 minutes 42 4/10 links; thence 133 degrees 30 minutes 4 chains 60 links; thence 88 degrees 30 minutes 42 4/10 links, and thence 43 degrees 30 minutes 70 links to the starting point.
