AN ACT to amend the Redistribution of Seats Act, 1929.

[Assented to 11th December, 1999.]

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

- 1. This Act may be cited as the Redistribution of Seats Short little. Act Amendment Act, 1929.
- 2. The Schedule to the Redistribution of Seats Act, 1929, Amendment of Schedule of is hereby amended as indicated in the Schedule to this Act. Redistribution of Seats Act, 1929.

THE SCHEDULE.

I. Strike out the description of the boundaries of the sec. 2. Canning Electoral District, and substitute a description as follows:—

- XI. In the description of the boundaries of the Williams-Narrogin Electoral District, strike out in line 33 of page 52 the figures "4150" and substitute "4105."
