ROADS CLOSURE.

No. 21 of 1930.

AN ACT for the Closure of portions of certain Roads.

[Assented to 11th December, 1930.]

B E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:---

Short title.

Closure of portions of Crowther and Francis streets, Geraldton.

Closure of portion of North road, Albany.

Closure of road-Royal Show Grounds. 1. This Act may be cited as the Roads Closure Act, 1930.

2. Those portions of Crowther and Francis streets in the Municipal District of Geraldton situated northward of the northern boundary of Marine terrace, are hereby closed; all rights of way over the same shall cease on the passing of this Act, and the said portions are hereby revested in His Majesty the King as of his former estate.

3. That portion of North road in the Municipal District of Albany extending from the production northward of the eastern boundary of Sanford road to the production southward of the eastern boundary of Rifle Range Reserve No. 918 is hereby closed, and all rights of way over the same shall cease on the passing of this Act, to the intent that the same may be acquired by the Commonwealth and be added to and form part of Defence Reserve No. 918.

4. That portion of road in the Municipal District of Claremont, being a strip of land one chain wide passing along the rorthern boundary of Swan Location 2266 from the eastern boundary of Graylands street to the production north of the eastern boundary of the said location is hereby closed, and all rights of way over the same shall cease on the passing of this Act, and the lands comprised in the said closed road may be granted to the Municipality of Claremont for an estate in fee simple, and the said municipality is hereby authorised and empowered to sell the said land to the Roval Agricultural Society Incorporated for a sum not exceeding Five hundred pounds: Provided, however, that the proceeds of sale shall be applied by the said municipality in or towards the construction of roads within its district.

5. That portion of Cemetery road in the Municipal Dis- Closure of portion of Cemetery road, trict of York lying between its intersection with the northern vork. boundary of Mount street and its junction with the southern boundary of Sidney road is hereby closed to the intent that the land comprised therein may be included in a reserve for a public cemetery.

That portion of Broome street in the Municipal Dis- Broome street, York, 6. trict of York which was closed by the Roads Closure Act, See Act No. 9 of 1929, is hereby vested in His Majesty the King as of his 1929, s. 2. former estate, and may be granted to the Municipality of York for an estate in fee simple in possession, free of encumbrances, and the said municipality is hereby authorised to sell and transfer the same.

7. That portion of Miriam street in the North Fremantle closure of portion municipal district extending from the Eastern side of Bracks North Fremantle. street to the western side of Napier street is hereby closed, and all rights-of-way over the same shall cease on the passing of this Act, and the land comprised therein is hereby revested in His Majesty as of His former estate.
