## AN ACT for the Closure of certain Roads.

[Assented to 9th December, 1924.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title.

Closure of portions of Fitzgerald Terrace, Fremantle.

1. This Act may be cited as the Roads Closure Act, 1924.
2. Those portions of Fitzgerald Terrace in the municipal district of Fremantle described in Part 1 of the Schedule to
this Act are hereby closed, and all rights-of-way over the district of Fremantle described in Part 1 of the Schedule to
this Act are hereby closed, and all rights-of-way over the same shall cease on the passing of this Act.
3. That portion of Patterson Street in the municipal district of Collie described in Part 2 of the Schedule to this Act is hereby closed, and all rights-of-way over the same shall cease on the passing of this Act.
4. Those portions of the Perth-Fremantle Road in the City of Perth described in Part 3 of the Schedule to this Act are hereby closed, and all rights-of-way over the same shall cease on the passing of this Act.
5. Angus Street, Flora Street, and Jessie Street, as de1227.

Closure of portions of Perth-Fremantle Road.

Closure of portion of Patterson Street, Collie. lineated on Plan No. 3008 of Swan Location 1227, deposited in the Office of Land Titles, are hereby closed, subject to a

 street being provided in lieu thereof extending from Wodonga Road to Vincent.Street, whereupon all rightsof-way over the closed streets shall cease.

## THE SCHEDULE.

## Part 1.

## IN THE MUNICIPALITY OF FREMANTLE.

## All those portions of Fitzgerald Terrace-

(a.) Bounded by lines starting at the West corner of Fremantle Town Lot 930 and extending $151^{\circ} 18^{\prime}, 2$ chains $24 \cdot 3$ links, to said lot's South corner; thence $248^{\circ} 50^{\prime}$, 5.5 links, along part of the North-Western side of Howard Street to the tangent point of a circular curve, the bearing and length of whose radius are $338^{\circ} 50^{\prime}$ and 59 links; thence North-Westerly by that curve 83 links; thence $329^{\circ} 23^{\prime}$, 51 links, and $327^{\circ} 33^{\prime}, 53 \cdot 2$ links, to the tangent point of a circular curve, the bearing and length of whose radius are $57^{\circ} 33^{\prime}$ and $57 \cdot 1$ links; thence Northerly by that curve $82 \cdot 2$ links, and thence $49^{\circ} 58^{\prime}, 16 \cdot 4$ links, along the South-Eastern side of Arundel Street to the starting point (Diagram 44699);
(b.) Bounded by lines starting at the West corner of Fremantle Town Lot 159, and extending $140^{\circ} 9^{\prime}$, I chain 92.3 links, along said lot's South-Western boundary and part of that of Lot 160 ; thence $230^{\circ} 27^{\prime}, 14.8$ links, and thence $324^{\circ} 29^{\prime}, 1$ chain 93 links, to the starting point. (Diagram 49588); and
(c.) Bounded by lines starting at the South comer of Fremantle Town Lot 161, said corner being the tangent point of a circular curve, the bearing and length of whose radius are $319^{\circ} 58^{\prime}$ and 28.5 links, and extending Westerly by said curve 47 links; thence $324^{\circ} 29^{\prime}, 1$ chain 64.9 links ; thence $50^{\circ} 27^{\prime}, 15 \cdot 9$ links, and thence $140^{\circ} 9^{\prime}$, 1 chain $95 \cdot 1$ links, along part of the South-Western boundary of Lot 160 and the whole of that of Lot 161 to the starting point. (Diagram 49588).

## Part 2.

## IN THE MUNICIPAL DISTRICT OF COLLIE.

All that portion of Patterson Street bounded by lines starting at a point situate $283^{\circ} 15^{\prime}$, and distant $10 \cdot 7$ links from the North-East corner of Collie Lot 1328, and extending $283^{\circ} 15^{\prime}, 50$ links; thence $200^{\circ} 34^{\prime}, 50$ links, to the tangent point of a circular curve, the bearing and length of whose radius are $110^{\circ} 34^{\prime}$ and $56 \cdot 8$ links from the said tangent point, and thence North-Easterly by said curve 82 links to the starting point.

Part 3.

## IN THE CITY OF PERTH.

All those portions of the Perth-Fremantle Road-
(a.) Bounded by lines starting at the intersection of the Northern side of said road with the Western side of Crawley Avenue, the said intersection being the tangent point of a clrcular curve, the bearing and length of the radius being $275^{\circ} 23^{\prime}$ and 2 chains $11 \cdot 3$ links, and extending South-Easterly by said curve 1 chain 27.4 links; thence $255^{\circ} 18^{\prime}, 4$ chains $94 \cdot 9$ links; thence $261^{\circ} 26^{\prime}, 9$ chains 36 links ; thence $750^{\circ} 18^{\prime}$, 11 chains $68 \cdot 8$ links, and thence $75^{\circ} 20^{\prime}, 3$ chains 33 links, to the starting point. (Diagram 49590.)
(b.) Bounded by lines starting at the North corner of Swan Location 2886, and extending $242^{\circ} 22^{\prime}$, I chain 81.6 links, to the tangent point of a circular curve, the bearing and length of the radius being $152^{\circ} 22^{\prime}$ and $82 \cdot 2$ links; thence by said curve in a South-Western direction 89.8 links; thence $359^{\circ} 46^{\prime}, 1$ chain $6 \cdot 3$ links; thence $62^{\circ} 22^{\prime}, 2$ chains $31 \cdot 7$ links, and thence $179^{\circ} 54^{\prime}, 56 \cdot 3$ links, to the starting point. (Diagram 43627.)
