## Health (Offensive Trades Fees) Regulations 1976

#### 1. Citation

These regulations are the *Health (Offensive Trades Fees)* Regulations 1976<sup>1</sup>.

#### 2. Application

These regulations have effect in every local government<sup>2</sup> district within the State.

#### 3. **Prescribed fees**

The fees set out in the Table to this regulation are payable on the registration of —

- the offensive trades specified in Schedule 2 of the Act; (a) or
- any process or class of trade declared to be an offensive (b) trade under section 186 of the Act.
