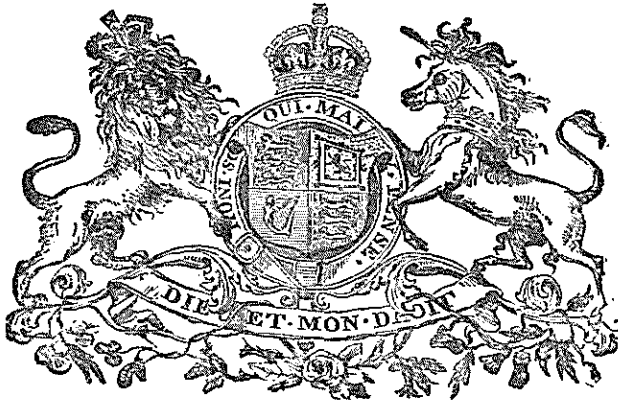

AN ACT to enable the purpose of certain
Permanent Reserves to be changed.

[Assented to 14th December, 1906.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. That portion of permanent reserve ^{AA} 9286, more particularly described in the First Schedule to this Act, being Kalgoorlie Lot 2791, and now dedicated to the purposes of park lands and drainage, is hereby excised from the said reserve, and is constituted reserve number [^] 10480, and dedicated to the purpose of a public school site.

2. That portion of permanent reserve ^{AA} 5183, more particularly described in the Second Schedule to this Act, being Perth Suburban Lot 454, and now dedicated to the purpose of public buildings, is hereby excised from the said reserve, and is constituted reserve number [^] 10380, and dedicated to the purpose of a Presbyterian Church.

3. That portion of permanent reserve ^{AΛ} 2101, more particularly described in the Third Schedule to this Act, and now dedicated to the purpose of a public park, is hereby excised from the said reserve, and is constituted reserve number ^Λ 10481, and dedicated to the purpose of a reservoir.

4. It shall be lawful for the mayor and councillors of the Municipality of Fremantle to demise to the Fremantle Golf Club, Incorporated, by a lease of which a copy is deposited in the office of the Department of Lands and Surveys in Perth, and marked "Land and Surveys $\frac{3375}{06}$," that portion of the permanent reserve numbered Λ 6638 therein described, for the term of fifteen years from the first day of April, one thousand nine hundred and six, at the rent and subject to the covenants, conditions, and reservations therein contained.

First Schedule.

All that portion of Permanent Reserve ^{AΛ} 9286 bounded by lines starting from the intersection of the South-Eastern side of Hay Street with the South-Western side of Throssell Street, Kalgoorli, and extending $133^{\circ} 30' 5$ chains 44 links; thence $223^{\circ} 30' 8$ chains 9 links; thence $313^{\circ} 29' 5$ chains 44 links to the South-Eastern side of Hay Street aforesaid, and along it $48^{\circ} 29' 8$ chains 9 links to the starting point, as surveyed and shown on Diagram 20095 in the Department of Lands and Surveys.

Second Schedule.

All that portion of permanent Reserve ^{AΛ} 5183, containing about 1 rood 13 perches, and bounded on the *North* by one chain of the South side of Bagot Road, Subiaco, and on the *East* by the West boundary of Perth Suburban Lot 404; the opposite boundaries being parallel and equal.

Third Schedule.

All that portion of permanent reserve ^{AΛ} 2101, bounded by lines starting from a point situate 1 chain $73\frac{3}{4}$ links North, and 5 chains 2 links West from the 25-Mile Post on the Eastern Railway, and extending South-Eastward along the South-Western side of a one chain road, running parallel with the said railway for a distance of 9 chains 6 links; thence $217^{\circ} 35' 8$ chains $42\frac{3}{4}$ links, $307^{\circ} 35' 9$ chains, and $37^{\circ} 35' 9$ chains 12 links to the starting point.
