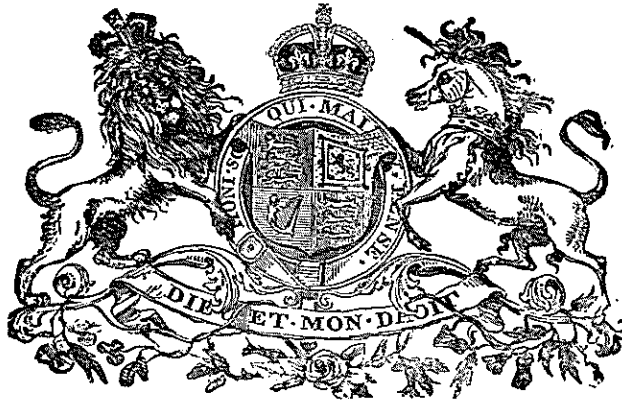

AN ACT for the Redistribution of Seats at Parliamentary Elections.

[Reserved 16th January, 1904.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. THIS Act may be cited as the *Redistribution of Seats Act*. Short title.
2. NOTWITHSTANDING anything contained in the Constitution Acts Amendment Act, 1899, to the contrary the ten Electoral Provinces shall be designated by the names stated in the first column of the First Schedule to this Act, and shall comprise the Electoral Districts stated in the second column of the said Schedule. Electoral Provinces.
First Schedule.
3. NOTWITHSTANDING the alteration by this Act of the boundaries of any Province, every member of the Legislative Council shall continue to represent in Parliament the Province of the same name as the Province for which he was elected, but with the boundaries assigned to it by this Act Seats of Members of
Council unaffected
by change of bound-
aries of Provinces.

Electoral Districts.

4. THE State shall be divided into fifty Electoral Districts, each returning one member to the Assembly.

Second Schedule.

5. NOTWITHSTANDING anything contained in the Constitution Acts Amendment Act, 1899, the fifty Electoral Districts shall, until otherwise determined by Parliament, be designated by the names stated in the first column of the Second Schedule to this Act, and the boundaries of each Electoral District shall be as described in the second column of the said Schedule.

Amendments to be passed by absolute majority of members of Council and Assembly.

6. IT shall not be lawful to present to the Governor for His Majesty's assent any Bill to amend this Act, unless the second and third readings of such Bill shall have been passed with the concurrence of an absolute majority of the whole number of the members for the time being of the Legislative Council and the Legislative Assembly respectively.

Proclamation of Royal assent and commencement of Act.

7. THIS Act shall be proclaimed by the Governor as soon as he shall have received a notification of the Royal assent thereto, and shall commence and take effect from the date of the publication of such proclamation in the *Government Gazette*.
