AN ACT to amend the Land Regulations proclaimed on the 2nd March, 1887.

[Assented to, 13th January, 1893.]

DE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Locisleting Communication with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

THE rent to be paid for pastoral leases in the Gascoyne, North-West, and Kimberley Divisions shall be: For each thousand Gascoyne, Northor part of a thousand acres, ten shillings each year for the whole West, and term of the lease; and clauses sixty-seven, sixty-nine, and seventyone of the Land Regulations proclaimed on the 2nd March, 1887, are hereby amended accordingly.

Kimberley Divisions.

THE rent to be paid for pastoral leases in the Eucla Division shall be: For all that portion of the Division situated to the West- Eucla Division. ward of a due North line from Point Culver, for each thousand or part of a thousand acres, ten shillings each year for the whole term of the lease; and in respect of all that portion of the Division to the Eastward of a due North line from Point Culver, shall be: For each thousand or part of a thousand acres, five shillings each year for the

Clause 73 of Land Regulations not to apply to certain portion of Eucla Division.

whole term of the lease; and clause sixty-eight of the Land Regulations proclaimed on the 2nd March, 1887, is hereby amended accordingly: Provided that clause seventy-three of the said Land Regulations shall not apply to that portion of the Eucla Division situated to the Eastward of a due North line from Point Culver, after the coming into operation of this Act.

Eastern Division.

- THE rent to be paid for Pastoral Leases in the Eastern Rent to be paid in Division shall be—For each thousand or part of a thousand acres, two shillings and sixpence for each of the first seven years, and five shillings for each of the remaining years of the lease; and clause seventy of the Land Regulations proclaimed on the 2nd March, 1887, is hereby amended accordingly.
- to apply to present and future leases.
- SECTIONS one, two, and three of this Act shall apply to Sections 1, 2, and 3 all leases already in existence, as well as to new leases to be applied for.

Extension of time under Clauses 50, 53, and 73.

THE provisions of clauses fifty and fifty-three, and of clause seventy-three as amended by this Act, of the said Land Regulations shall have force for fourteen years instead of five years, as therein respectively provided, and clause fifty-three shall apply to the Eastern Division in the same manner as to the other Divisions therein named.

Act and Land Regulations of 1887 to be read together.

THIS Act shall be read and construed with the Land Regulations proclaimed on the 2nd March, 1887, in so far as those Regulations are not repugnant to this Act, and shall come into operation on the first day of January, one thousand eight hundred and ninety-three.
