NO. I.

AN ORDINANCE to declare the Trusts upon which Churches, Chapels, and Ministers' Dwellings belonging to the Religious Society called Wesleyan Methodists shall be held.

[15th July, 1867.]

WHEREAS it is expedient to make provision for the settlement of all Chapels and Ministers' Dwellings belonging to the religious Society denominated Wesleyan Methodists, and that all such property be held upon uniform trusts and according to the usages of such Society; Be it therefore enacted by His Excellency the Governor of Western Australia and its dependencies, by and with the advice and consent of the Legislative Council thereof,

ALL Churches, Chapels, Ministers' Dwellings and other pro- trustshereinafter mentioned perty belonging to the said Society, held by any Trustees thereof, shall be so held upon the trusts hereinafter mentioned.

Wesleyan's Churches &c.

Trustees of Churches &c., required to convey Trust premises to Trustees elected Society.

IT shall be lawful for the Trustees, or the survivors or survivor of them, or the heirs of such survivor, in whom any Church, Chapel, according to usages of such Minister's Dwelling, or other property belonging to the said Society shall be vested for the time being, and they and he are hereby authorised and required, at the request in writing of any three or more members of the said Society, to convey the said trust premises with any lands and hereditaments thereunto belonging, to any number of Trustees to be nominated and elected according to the usages of such Society as aforesaid, not being less than three, and their heirs, to hold the real estate of and in the same hereditaments to the use of such Society; But nevertheless upon such and the same trusts, and to and for such and the same ends, intents, and purposes, and with under and subject to such and the same powers provisoes declarations and agreements, as are expressed contained and declared or referred to, in and by a certain Indenture of Release bearing date on or about the third day of July in the year of our Lord one thousand eight hundred and thirty-two, and made or expressed to be made between John Sutcliffe, Benjamin Garside, Francis Farnell, John Swallow, Thomas Firth, Robert Wilson, Samuel Naylor, John Fearby Sutcliffe, Thomas Fox Sutcliffe, Charles Swallow, John Swallow the Younger, Samuel Morley, Joseph Garside accountant, William Farnell and Joseph Garside wood turner, therein respectively described of the first part, the Reverend George Marsden. therein described of the second part, and James Brown, therein also described of the third part, and enrolled in Her Majesty's High Court of Chancery on the twenty-fifth day of July, one thousand eight hundred and thirty-two, being a deed made of the settlement of a piece or parcel of land, ground, and Chapel or place of religious worship, with the appurtenances situate at Skircoat in the parish of Halifax and county of York, for the use of the people called Methodists in the connexion established by the late Reverend John Wesley.
