AN ORDINANCE to confirm the Expenditure for the Services of the year 1863, beyond the grant for that year.

[11th July, 1864.]

Preamble.

HEREAS by an Ordinance of the Legislative Council made and passed in the Twenty fifth year of Victoria, No. 17, of 1862, the sum of Sixty seven thousand, eight hundred, and three pounds was granted and applied for the services of the year One thousand Eight hundred and Sixty three; And whereas there has been expended for the services of the said year, in excess of the grants made for the several services in the Account hereto annexed, the sum of Seven thousand, three hundred, and twenty five pounds, twelve shillings: Be it enacted by His Excellency The Governor of Western Australia, and its Dependencies, by and with the advice and consent of the Legislative Council thereof, as follows:

#### Excess of Expenditure.

Excess of Expenditure for 1865 confirmed. 1. THE sums issued and applied for the services of the year cnded the Thirty first day of December, One thousand Eight hundred and Sixty three, beyond the grant obtained for the same year, that is to say, the sum of Seven thousand, three hundred, and twenty five pounds, twelve shillings, be and the same is hereby confirmed and allowed, and is hereby declared to be a charge against the general Revenues of the Colony.
