## No. IX.

An Ordinance for the further Appropriation of the Revenue for the Year 1856, and for the General Appropriation of the Revenue for the Year 1858.

HEREAS by the Laws relating to the Customs and Trade, and other Acts and Ordinances of this Colony, certain duties, fines, and other monies are or may be imposed, levied, and collected, to be paid to the Colonial Treasurer, on behalf of Her Majesty, her heirs and successors, for the Public uses of the Colony and in support of the Government thereof: Be it therefore enacted, Preamble. by His Excellency the Governor of Western Australia and its Dependencies; by and with the advice and consent of the Legislative Council thereof:—

I. THAT out of the said duties, and the produce of all, or any other the General Public Revenues of the Province, not otherwise by law specially appropriated, there shall or may be further issued Appropriation of the and applied, in the manner hereinafter provided, for the several Revenue.

FIRSTLY, for defraying the excess of Expenditure for the Go-Excess of Expendi vernment Establishments and Miscellaneous Services beyond the grants for the Year ended the 31st day of December, 1856, the sum of Three thousand one hundred and fifty-two pounds, four shillings; the said amount being appropriated as follows, viz.:-

For Salaries and Allowances.—

Colonial Secretary, Two hundred and nineteen pounds, Eight shillings and sevenpence.

Clerk of Councils, One hundred and twenty-four pounds, Fourteen shillings and fourpence.

Surveyor General, Forty-six pounds, Nine shillings and four-

Judicial Establishment, Fifty-seven pounds, Eight shillings and eightpence.

For Rottnest Penal Establishment (exclusive of establishments), Four hundred and fifty pounds.

For Rent, Two hundred and twenty-five pounds.

For Transport, Three hundred pounds.

For conveyance of Mails, One thousand six hundred pounds.

For Works and Buildings, One thousand nine hundred and fifty pounds.

For Roads and Bridges, Two thousand pounds.

For Miscellaneous Services, Two hundred and thirty pounds.

For Immigration, Two hundred and fifty pounds.

For Aborigines (exclusive of establishments), Five hundred and ninety-two pounds.

For Harbour Master (exclusive of establishments), Four hundred pounds.

For Payment of Debts, Four thousand two hundred and seven pounds, Ten shillings and tenpence.

Amounting in the whole to the above sum of Fifty-one thousand and thirty pounds.

II. AND be it enacted, that the Colonial Treasurer shall issue and pay from time to time any sum or sums of money, for the purposes hereinbefore mentioned, not exceeding in the whole the sums respectively in that behalf hereinbefore specified, to such persons, and in such portions, as the Governor for the time being shall by an order or orders in writing signed by him, from time to time Colonial Treasurer to pay on the orders of direct, and the said Treasurer shall, in his accounts, be allowed Governor, and discredit for all sums paid by him in pursuance of such orders charged by receipt of accordingly; and the receipts of the persons to whom such sums shall have been so paid shall be to him a full discharge for the sum or sums for which the same receipts shall have been respectively given, and the amount thereof shall be passed to his credit in account accordingly.
