An Act for applying certain Sums arising from the Revenue receivable in the Colony of Western Australia to the Service thereof, for the Financial Year commencing first April, one thousand eight hundred and forty-two.

Miscellaneous Contingen and any sum or sums not exceeding One thousand pounds to defray the expenses of Miscellaneous Contingencies which may arise in the course of the year.

Treasurer to pay over sallaries, &c., as the Go-Colony shall issue and pay the said sums to such persons, for the purposes hereinbefore mentioned, upon such days, and in such proportions as the Governor for the time being, by any warrant or order in writing so signed by him, shall from time to time order and direct; and that the payment so made shall be charged upon and payable out of the Revenue of the said colony.

Receipts of parties to be III. AND be it further enacted, that the said Treasurer shall in sufficient discharge to his accounts from time to time be allowed credit for any sum or sums of money paid by him in pursuance of such warrant or order in writing as aforesaid, and that the receipt or receipts of the respective persons to whom the same shall be so paid, shall be a full and valid discharge to the said Treasurer in passing his said accounts for any such sum or sums of money as shall be therein mentioned, and that he shall and do receive credit for the same accordingly.
