An Act to regulate the Licensing of Auctioneers, and the collection of Duties on Property sold by Auction.

HEREAS it is expedient to establish Regulations relative to Preamble. the licensing of Auctioneers, and the collection of duties ou all kinds of property which shall, from and after the passing of this Act, be sold by Auction in the said colony; -Be it therefore enacted, by His Excellency the Governor of Western Australia and its Dependencies, by and with the advice and consent of the Legislative Council thereof, that from and after the passing of this Act, no person who Auctioneers required to shall exercise the trade or business of an Auctioneer, or seller by commission, at any sale of any estate, goods or effects whatsoever, by outcry, knocking down of hammer, by candle, lot, parcel, or any other mode of sale at auction, or whereby the highest bidder is deemed to be the purchaser, or who shall act in that capacity, shall deal in, sell, or put up to sale, any estate, goods or effects whatsoever by public sale, or by way of auction, as aforesaid, without previously having taken out a license according to the form contained in the schedule hereunto annexed; in which license shall be set forth, the true name and real place of abode of the person taking out the same; such per-

son immediately upon taking out of such license, paying down for the same the sum of Ten Pounds sterling for selling by auction in any and every part of the colony, and the sum of Five Pounds sterling for selling in any part of the said Colony except in the towns of Perth and Fremantle.

Manner of applying for a License, and surcties to be given by persons obtaining a License.

II. AND be it further enacted, that every person who shall be desirous of obtaining an Auctioneer's License shall apply for the same in writing to the Bench of Magistrates nearest to his usual place of residence, and such Bench of Magistrates, if they be satisfied that such applicant is a person of unexceptionable character, shall, and they are hereby authorised and required to deliver to such applicant a certificate under their hands to that effect, and upon presenting such certificate to the Collector of Internal Revenue of the said colony, or to such other officer as the Governor or acting Governor shall from time to time appoint, such Collector, or other officer so appointed, shall issue and deliver to the person so applying such a license as is required by this Act: Provided, always, that no such license shall be granted until the person applying for the same shall have lodged in the hands of such Collector, or such other officer as aforesaid, a bond to Her Majesty, Her Heirs and Successors, with two sufficient sureties, in manner following,—that is to say,—to any person for a license to sell in any part of the colony, himself in the sum of Two Hundred Pounds, and his sureties in the sum of One Hundred Pounds each, and for a license to sell by auction in any other part of the said colony except in Perth or Fremantle, himself in One Hundred Pounds, and his sureties in the sum of Fifty Pounds each, that he shall and will deliver every account of the sales by him made, and also make payment of all and every sum and sums arising or becoming due for the auction duty payable for or in respect of all such sales in the manner hereinafter directed.

License to be renewed every year, under a penalty.

III. AND be it further enacted, that every person who shall take out such license as aforesaid is hereby required to take out a fresh license, ten days at least before the expiration of twelve calendar months after the taking out of the first license, before he presumes to vend or sell by way of auction, as aforesaid; and in the same manner to renew every such license from year to year, paying down a like sum as at first for each and every new or renewed license, as aforesaid; and if any person shall presume or offer to vend or sell by way of auction, as aforesaid, without taking out such license, or renewing the same yearly, in the manner aforesaid, such person shall forfeit, for every such offence, the sum of Ffty Pounds.

A duty of 2½ per cent on proceeds of all sales by auction.

IV. AND be it further enacted, that there shall be raised, levied, collected, and paid, in such manner as hereinafter is mentioned, to

and for the use of Her Majesty, Her Heirs and Successors, in aid of the Colonial Fund, for and upon all manner of sales by auction within the said colony, the duty hereinafter expressed,—that is to say, at the rate of Two Pounds Ten Shillings for each and every One Hundred Pounds arising from the sale by auction of any estate, goods or effects whatsoever, the said duty to be paid by every such Auctioneer, or seller by commission, out of the monies arising at each and every such sale or auction, as aforesaid.

V, AND be it further enacted, that the said duty by this Act The above duty a charge imposed shall be, and is hereby declared to be, a charge upon every upon the auctioneer from Auctioneer, or seller by commission, immediately from and after the the closing of the bidding at every sale. knocking down of the hammer, or other closing of the bidding, at every sale by way of auction, and that the duty so charged shall be paid by every such Auctioneer, or seller by commission, in manner and at the times hereinafter mentioned.

VI. AND be it further enacted, that each and every person Account of all sales to be so acting as Auctioneer, as aforesaid, shall, and he is hereby days after the expiration required, within fourteen days after the expiration of every of every month. calendar month, to deliver, or cause to be delivered, to the Collector of Internal Revenue for the time being, or at his office, or to such other person as shall from time to time be authorised to receive the same, an exact and particular account in writing of the total amount of money that shall have been bidden at each and every sale, and of the several articles, lots, or parcels, with the price at which every such article, lot or parcel, shall have been sold at each and every sale which shall have been had and holden by such Auctioneer during the said month, together with the time or times when, and the place or places where, such sale or sales shall have been had and holden; and every such Auctioneer shall at the same time make payment to the said Collector of Internal Revenue of all such sum and sums of money as shall be due and payable to Her Majesty in pursuance of, and according to, the true intent and meaning of this Act, which sum or sums of money the said Auctioneer is hereby Auctioneer is authorised authorised and empowered to retain out of the produce arising by to retain the above duty such sale, or deposit made at such sale, or otherwise to recover the from the proceeds of sale. same by action at law against the person or persons by whom such the truth of his account. and in manner aforesaid, or to make payment of the duty as hereinbefore directed, or if it shall appear that the account delivered in by such Auctioneer is not a true and just account, or that the said In case of judgment being Auctioneer hath acted contrary to the true intent and meaning of this Act, it shall and may be lawful for the said Collector, or other person so to be appointed as aforesaid, to cause the bond or bonds of such Auctioneer, and his sureties, to be put in suit, and in case of a judgment being thereupon had against the defendant, such license shall thenceforth become void to all intents and purposes: and such Auctioneer shall be, and he is hereby declared to be, for ever after disqualified for holding any license as an Auctioneer, unless it shall appear to the satisfaction of the Court, or Judge, before whom the trial of such bond shall have been had, that no fraud or wilful delay, contrary to the true meaning of this Act, was intended by such Auctioneer, and a certificate to such effect shall be granted by such Court or Judge respectively.

If sales by Auction are rendered null and void. the duty paid thereon is to be returned,

VII. AND whereas it may sometimes happen that sales at auction of estates or good may be rendered null and void by reason that the person or persons for whose benefit the same shall be sold had no title to, or no right to dispose of the same; -Be it therefore enacted, that if any sale by auction of any estate, goods or effects, shall be rendered void by reason that the person for whose benefit the same was sold had no title to the same, or no right to dispose thereof, then, and in every such case, it shall and may be lawful for the Auctioneer who paid the duty for the estates, goods or effects so sold, or for the person or persons for whose benefit the same were sold, to apply to the said Collector, or to the person who shall be appointed as aforesaid, for a return of the duty so paid; and the said Collector, or the person so appointed, as aforesaid, shall, and is hereby required to hear and investigate all such applications, and examine the witnesses upon oath who shall be produced on the part of the party or parties making such application, which oath the said Collector, or other person appointed as aforesaid, is hereby empowered to administer, and thereupon to report the case to the said Governor, who, upon being satisfied as to the justness of the application, may order the amount of duty which shall have been so paid, as aforesaid, to be refunded to such Auctioneer, or such other person on whose behalf the same shall have been originally paid to such Collector, or other person appointed as aforasaid; anything in this Act to the contrary not withstanding.

VIII. PROVIDED also, and be it further enacted, that in case the In case the owner of any puachaser, a remission of real owner of any estate, goods or effects put up to sale by way of the duty arising by this auction shall become the purchaser by auction, shall become the purchaser by means of his own bidding, or Act, will be made. the bidding of any other person on his behalf, or for his use, at such

cale, without fraud or collusion, then, and in such case, the Collector, or other person appointed to receive the duty, is respectively hereby authorised and empowered to make a remission to such owner of the duty arising by this Act upon such bidding, provided notice be given to the Auctioneer before such bidding both by the owner and the person intended to be the bidder, of the latter being appointed by the former, and having agreed accordingly to bid at the sale for the use and behoof of the seller, and provided such notice be verified, if required, by the written declaration of the Auctioneer, as also by evidence to be given of the fairness and reality of the transaction, according to the best of his knowledge and belief; and in case any dispute shall arise whether such purchase by the owner was not made by collusion, or in order to lessen the full sum appainted by this Act to be paid, or concerning the fairness of such transaction, then, and in such cases, the proof thereof shall lie upon the person acting as Auctioneer; and on failure therein, or in case of any unfair practice, then no such remission shall be made as aforenid.

IX. PROVIDED always, and it is hereby further enacted, that goods sold by order of the nothing in this Act contained shall extend to any sale or sales by Court; of Collector of Revenue: nor to sales of auction of estates or chattels made by any rule, order or Government Land; nor to decree of the Civil Court of the said colony in pursuance of its sales or purchases made equitable jurisdiction, or by order of the Collector or any acting goods distrained for rent; Collector of Revenue within the said Colony, nor to sales by auction or sold by order of Justice of Government land by any of its public officers, nor to sales or purchases made by or on account of the Government, nor to sales by auction of any goods distrained for rent, or goods sold by distress by order of any Justice of the Peace; anything hereinbefore to the contrary notwithstanding.

XII.
