### **Marine Navigational Aids Regulations 1985**

#### 1. Citation

These regulations may be cited as the *Marine Navigational Aids Regulations 1985*<sup>1</sup>.

#### 2. Commencement

These regulations shall come into operation on the coming into operation of the *Marine Navigational Aids Amendment Act 1978*<sup>1</sup>.

#### **3.** Fees payable in respect of fishing boats

- (1) The master and the owner of a fishing boat other than a fishing boat
  - (a) which does not exceed 5.5 metres in length exclusive of bowsprit;
  - (b) engaged solely in fishing in estuaries or inland waters; or
  - (c) for which conservancy dues are prescribed as payable under the *Ports and Harbours Regulations 1966*<sup>2</sup> made under the *Shipping and Pilotage Act 1967*,

are jointly and severally liable to pay to the Department the fee set out in Schedule 1 that is appropriate to that fishing boat.

(2) The fee referred to in subregulation (1) is payable —

#### r. 3

(a)	for the period ending 30 June 1986, on
	1 September 1985; and

(b) for each period of 12 months ending on 30 June in any year after 1986, on 1 July in the preceding year.

The fees in the Table are payable in respect of the provision of marine navigational aids outside any port under the control of a port authority and the approaches to that port.

Not more than 6 m	116.40
More than 6 m but not more than 10 m	152.40
More than 10 m but not more than 20 m	223.00
More than 20 m but not more than 30 m	342.50
More than 30 m but not more than 50 m	522.60
More than 50 m	816.70
