AN ACT to amend the Explosives Act, 1895.

[Assented to, 7th October, 1902.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:----

1. THIS Act may be cited as the Explosives Act Amendment Short title. Act, 1902, and shall be read as one with the Explosives Act, 5895, hereinafter referred to as the principal Act.

THE Governor may from time to time appoint and remove Government may 2. sub-inspectors of explosives, and may assign to them their duties.

appoint subinspectors.

A notification of every such appointment and removal shall be published in the Government Gazette.

* Explosives Act—Amendment.

3. A SUB-INSPECTOR of explosives may, in the performance of the duties assigned to him, exercise all the powers of an inspector of explosives under the principal Act.

4. ANY inspector or sub-inspector may attend any inquest on the bodies of persons whose death may have been caused by the explosion of any explosive, or by any accident in connection with an explosive, and shall be at liberty at any such inquest to examine any witness.

5. SECTION twenty-one of the principal Act is amended by striking out the words "as he may fix from time to time not exceeding those in the Schedule," and by inserting in lieu thereof the words "as are set forth in the Schedule."

6. SO much of the Schedule to the principal Act as prescribes the maximum fees for licenses granted by the Treasurer is repealed, and the Schedule to this Act is substituted therefor.

In the name and on behalf of the King I hereby assent to this Act.

Amending License	Five pounds.
Annual Renewal of License	Five pounds.
MAGAZINE LICENSES :	
For any quantity up to 500lbs.	One pound per annum.
Exceeding 500lbs. and up to 10,000lbs.	One pound ten shillings per annum.
For quantity over 10,000lbs	Two pounds per annum.
Amending License	Five shillings.
STORE LICENSES :	
In mode (a)	Fifteen shillings per annum.

For sale of Fireworks only	Five shillings per annum.
LICENSE TO IMPORT :	
Original Renewal	Two pounds.
Renewal	Five shillings
