## **Petroleum Products Subsidy Regulations 1966**

#### 1. Citation

These regulations may be cited as the *Petroleum Products* Subsidy Regulations 1966<sup>1</sup>.

#### 2. Interpretation

In these regulations, **"the Act"** means the *Petroleum Products Subsidy Act 1965*.

#### 3. Claim for payment (section 7)

For the purposes of section 7 of the Act, a claim, by a registered distributor of petroleum products, for payment under the Act shall —

- (a) be made on a form supplied for the purpose by an authorised officer;
- (b) include the information required by the form;
- (c) be signed by the distributor or by a person authorised by the distributor;
- (d) be accompanied by a summary of the sales of eligible petroleum products to which the claim relates; and
- (e) be sent by post to, or lodged with, the Office of the Regional Director, AusIndustry, Department of Industry Science and Resources in Brisbane.
