### **Salaries and Allowances Regulations 1975**

#### 1. Citation

These regulations may be cited as the *Salaries and Allowances Regulations* 1975<sup>1</sup>.

#### 2. Interpretation

In these regulations, unless the context requires otherwise, *the Act* means the *Salaries and Allowances Act 1975*. *[Regulation 2 amended in Gazette 23 Jan 1981 p. 388.]* 

#### **3. Prescribed offices**

The offices created or established under the written laws specified in column 1 of the Schedule and specified in column 2 of that Schedule opposite and corresponding to those written laws are prescribed offices for the purposes of section 6 of the Act.
