Offshore Minerals (Registration Fees) Regulations 2010

1. Citation

These regulations are the *Offshore Minerals (Registration Fees) Regulations 2010.*

2. Commencement

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day on which the provisions of the *Offshore Minerals Act 2003*, other than sections 1 and 2, come into operation.

3. Prescribed percentage for s. 4(1)

For the purposes of section 4(1) of the Act, the prescribed percentage is 1.5%.

4. Prescribed minimum amount for s. 4(3)

For the purposes of section 4(3) of the Act, the prescribed minimum amount is \$600.

5. Prescribed amount for s. 6(1)

For the purposes of section 6(1) of the Act, the prescribed amount is \$3 000.
