

# Endnotes, Compilation table, and Table of provisions that have not come into operation

- 1. Details about the original regulations are shown in the Compilation table in endnote 1, at the back of the reprint. The table also shows any previous reprint.
- 2. A table of provisions that have not come into operation, to be found in endnote 1a if it is needed, lists any provisions that would amend the text if they were to come into operation. The table refers to another endnote setting out the text of the amendments in full.

#### Notes amongst text (italicised and within square brackets)

Editorial notes show if something has been omitted under the *Reprints Act 1984* s. 7(4) (because, although still technically part of the text, it no longer has any effect).

The text of anything omitted can be found in an earlier reprint (if there is one) or the regulations as published.

#### Reprint numbering and date

- 1. The reprint number (in the footer of each page of the document) shows how many times the regulations have been reprinted. For example, numbering a reprint as "Reprint 3" would mean that the reprint was the 3<sup>rd</sup> reprint since the regulations were published. Reprint numbering was implemented as from 1 January 2003.
- 2. The information in the reprint is current on the date shown as the date as at which the regulations are reprinted. That date is not the date when the reprint was published by the State Law Publisher and it is probably not the date when the most recent amendment had effect.

# Art Gallery Act (Common Seal) Regulations 1979

## 1. Citation

These regulations may be cited as the *Art Gallery Act (Common Seal) Regulations 1979*<sup>1</sup>.

### 2. Definitions

In these regulations, unless the context otherwise requires —

"Administrative Officer" means the officer appointed by the Board as the Administrative Officer;

"common seal" means the common seal of the Board; "the Act" means the *Art Gallery Act 1959*.

### **3.** Form of common seal

Whereas the form of the common seal was, until immediately before the date of coming into operation of these regulations, the form set out in regulation 3 of the *Art Gallery Act Regulations 1961* published in the *Government Gazette* on 20 September 1961, the form of the common seal on and after

that first mentioned date is the form set out in the Schedule to these regulations.

### 4. Safe custody and affixing common seal

- (1) The Director or, in his absence, the Administrative Officer shall keep the common seal in safe custody.
- (2) The common seal shall not be affixed to a document unless
  - (a) the Board has directed by a resolution at one of its regular meetings that the common seal be affixed to the document; and
  - (b) the common seal is affixed to the document by the Director or, in his absence, the Administrative Officer in the presence of the chairman or, in his absence, one of the other members of the Board.
