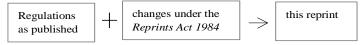

#### What the reprint includes



## Endnotes, Compilation table, and Table of provisions that have not come into operation

- 1. Details about the original regulations are shown in the Compilation table in endnote 1, at the back of the reprint. The table also shows any previous reprint.
- 2. A table of provisions that have not come into operation, to be found in endnote 1a if it is needed, lists any provisions that would amend the text if they were to come into operation. The table refers to another endnote setting out the text of the amendments in full.

#### Notes amongst text (italicised and within square brackets)

Editorial notes show if something has been omitted under the *Reprints Act 1984* s. 7(4) (because, although still technically part of the text, it no longer has any effect).

The text of anything omitted can be found in an earlier reprint (if there is one) or the regulations as published.

#### Reprint numbering and date

- 1. The reprint number (in the footer of each page of the document) shows how many times the regulations have been reprinted. For example, numbering a reprint as "Reprint 3" would mean that the reprint was the 3<sup>rd</sup> reprint since the regulations were published. Reprint numbering was implemented as from 1 January 2003.
- 2. The information in the reprint is current on the date shown as the date as at which the regulations are reprinted. That date is not the date when the reprint was published by the State Law Publisher and it is probably not the date when the most recent amendment had effect.

## **Building Disputes Committee Regulations 1992**

## 1. Citation

These regulations may be cited as the *Building Disputes* Committee Regulations 1992<sup>1</sup>.

## 2. Jurisdiction that may be given to registrar

The jurisdiction set out in the Table to this regulation is prescribed, for the purposes of section 33(2) of the Act, as jurisdiction that the registrar may exercise with the written approval of the Disputes Committee or the chairperson of that Committee.

### Table

- A. The hearing of a complaint under section 12A of the Act and the determination of the complaint by the making of one of the following orders
  - (a) an order under subsection (1)(a) or (1a)(a) of that section to remedy building work; or

(b)	an order under subsection (1)(b) or (1a)(b) of that
	section for the payment of costs or compensation
	but not exceeding an amount of \$5 000.

- B. The hearing of an application under subsection (1) of section 17 of the *Home Building Contracts Act 1991* and the determination of the application by making an order under subsection (4)(a) of that section.
- C. The hearing of an application under subsection (1) of section 18 of the *Home Building Contracts Act 1991* and the making of an order under that subsection.
