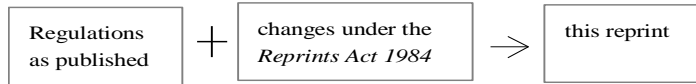

# **Dividing Fences Regulations 1971**

## Guide for using this reprint

### *What the reprint includes*



### *Endnotes, Compilation table, and Table of provisions that have not come into operation*

1. Details about the original regulations are shown in the Compilation table in endnote 1, at the back of the reprint. The table also shows any previous reprint.
2. A table of provisions that have not come into operation, to be found in endnote 1a if it is needed, lists any provisions that would amend the text if they were to come into operation. The table refers to another endnote setting out the text of the amendments in full.

### *Notes amongst text (italicised and within square brackets)*

Editorial notes show if something has been omitted under the *Reprints Act 1984* s. 7(4) (because, although still technically part of the text, it no longer has any effect).

The text of anything omitted can be found in an earlier reprint (if there is one) or the regulations as published.

### *Reprint numbering and date*

1. The reprint number (in the footer of each page of the document) shows how many times the regulations have been reprinted. For example, numbering a reprint as “Reprint 3” would mean that the reprint was the 3<sup>rd</sup> reprint since the regulations were published. Reprint numbering was implemented as from 1 January 2003.
2. The information in the reprint is current on the date shown as the date as at which the regulations are reprinted. That date is not the date when the reprint was published by the State Law Publisher and it is probably not the date when the most recent amendment had effect.

## Dividing Fences Regulations 1971

### 1. Citation

These regulations may be cited as the *Dividing Fences Regulations 1971*<sup>1</sup>.

### 2. Interpretation

In these regulations —

“open spaces”, “public”, “rights of way”, “roads”, “streets”,  
have the same respective meanings as they have in and for  
the purposes of the *Town Planning and Development  
Act 1928*; and

“the Act” means the *Dividing Fences Act 1961*.

### 3. Exclusion from meaning of “owner”

Under and for the purposes of the Act “owner” does not  
include —

- (a) any trustees or other persons in whom land is vested; or

(b) a person who has the care, control and management of  
land used,

for open spaces, streets, roads, or rights of way that are public.
