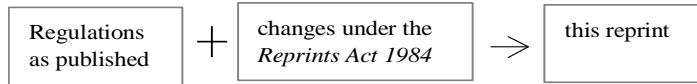

# **PathCentre (Common Seal) Regulations 1995**

## Guide for using this reprint

### *What the reprint includes*



### *Endnotes, Compilation table, and Table of provisions that have not come into operation*

1. Details about the original regulations are shown in the Compilation table in endnote 1, at the back of the reprint. The table also shows any previous reprint.
2. A table of provisions that have not come into operation, to be found in endnote 1a if it is needed, lists any provisions that would amend the text if they were to come into operation. The table refers to another endnote setting out the text of the amendments in full.

### *Notes amongst text (italicised and within square brackets)*

Editorial notes show if something has been omitted under the *Reprints Act 1984* s. 7(4) (because, although still technically part of the text, it no longer has any effect).

The text of anything omitted can be found in an earlier reprint (if there is one) or the regulations as published.

### *Reprint numbering and date*

1. The reprint number (in the footer of each page of the document) shows how many times the regulations have been reprinted. For example, numbering a reprint as "Reprint 3" would mean that the reprint was the 3<sup>rd</sup> reprint since the regulations were published. Reprint numbering was implemented as from 1 January 2003.
2. The information in the reprint is current on the date shown as the date as at which the regulations are reprinted. That date is not the date when the reprint was published by the State Law Publisher and it is probably not the date when the most recent amendment had effect.

## PathCentre (Common Seal) Regulations 1995

### 1. Citation

These regulations may be cited as the *PathCentre (Common Seal) Regulations 1995*<sup>1</sup>.

### 2. Commencement

These regulations come into operation on 10 April 1995.

### 3. Interpretation

In these regulations unless the contrary intention appears —

“**agency board**” means the agency board by which PathCentre is constituted;

“**common seal**” means the common seal of PathCentre;

“**PathCentre**” means the agency established under section 7B(1) of the Act under the name “The Western Australian Centre for Pathology and Medical Research”.

**4. Form of common seal**

The common seal shall be in the form of 2 concentric circles containing the words “The Western Australian Centre for Pathology and Medical Research” between the circles.

**5. Use of common seal**

The common seal may be affixed to all documents and classes of documents that the agency board has authorised to be sealed with the common seal.

**6. Execution of documents**

A document is duly executed by PathCentre if the common seal is affixed to the document in the presence of 2 members of the agency board and if both of those members sign the document to attest that the common seal was so affixed.
