

What the reprint includes



Endnotes, Compilation table, and Table of provisions that have not come into operation

- 1. Details about the original regulations are shown in the Compilation table in endnote 1, at the back of the reprint. The table also shows any previous reprint.
- 2. A table of provisions that have not come into operation, to be found in endnote 1a if it is needed, lists any provisions that would amend the text if they were to come into operation. The table refers to another endnote setting out the text of the amendments in full.

Notes amongst text (italicised and within square brackets)

Editorial notes show if something has been omitted under the *Reprints Act 1984* s. 7(4) (because, although still technically part of the text, it no longer has any effect).

The text of anything omitted can be found in an earlier reprint (if there is one) or the regulations as published.

Reprint numbering and date

- 1. The reprint number (in the footer of each page of the document) shows how many times the regulations have been reprinted. For example, numbering a reprint as "Reprint 3" would mean that the reprint was the 3rd reprint since the regulations were published. Reprint numbering was implemented as from 1 January 2003.
- 2. The information in the reprint is current on the date shown as the date as at which the regulations are reprinted. That date is not the date when the reprint was published by the State Law Publisher and it is probably not the date when the most recent amendment had effect.

Water Boards Act 1904

Water Boards (Bunbury) Regulations 1997

1. Citation

These regulations may be cited as the *Water Boards (Bunbury) Regulations 1997*¹.

2. Definition

In these regulations —

"Bunbury Water Board" means the Water Board for the Water Area that was constituted as the Bunbury Water Area by Order in Council published in the *Gazette* on 5 January 1906.

3. Membership of Bunbury Water Board

- (1) The Bunbury Water Board, as constituted by the appointment of the members by the Governor under the *Water Boards (Bunbury Water Board Constitution) Order 1997*, is to consist of 6 members.
- (2) Each member is to hold office for such period, not exceeding3 years, as is fixed by the member's instrument of appointment,
