#### MOTOR VEHICLE DRIVERS INSTRUCTORS REGULATIONS, 1964.

These regulations may be cited as the Motor Vehicle Drivers 1. Instructors Regulations, 1964.

In these regulations, "the Act" means the Motor Vehicle Drivers Instructors Act, 1963, and, unless the context otherwise requires, words and expressions used in these regulations have the same respective meanings as are given them in, and for the purposes of, the Act.

3. Every application for a licence shall be made in the form of Form 1 in the schedule to these regulations.

4. A licence shall be in the form of Form 2 in the schedule to Substituted these regulations.

(1) In any case where the Authority requires an applicant Amended by the holder of a licence to undergo a medical test, the licence G.G. 30/5/75, 5. for, or the holder of, a licence to undergo a medical test, the licence shall not issue or, as the case may require, the licence is inoperative, until the applicant or holder produces the certificate of a legally qualified medical practitioner, nominated by the Authority certifying that, in the opinion of the medical practitioner, the applicant or holder is physically fit to act as a motor vehicle driving instructor.

(2) Every medical certificate obtained pursuant to this regulation shall-

- (a) be in a form required or supplied by the Authority; and
- (b) speak as to the visual acuity of the applicant for, or holder of, the licence.

6 The holder of a licence or permit shall, within three days Amended by G.G. 30/5/75, after its expiration, suspension or cancellation, deliver up the licence p. 1604. or permit to the Authority.

Where, subsequent to the issue of the licence or permit, the Amended by r changes his address, he shall notify the Authority of that G.G. 30/5/75, p. 1604. holder changes his address, he shall notify the Authority of that fact, within seven days after the change.

8. The holder of a licence or permit shall produce it for inspec-tion, at the request of a patrolman, officer of the Authority, Traffic Amended by G.G. 30/5/75, p. 1604; G.G. 9/7/76, Inspector or a person wishing to receive, or who has received, driving instructions from the holder. 2367

9. Where the Authority is satisfied that a licence or permit has Amended by been lost, mutilated, or destroyed, he may, on payment of the fee G.G.30/5/75, prescribed by these regulations, cause a replacement licence or p. 1605. p. 1605. of no force or effect.

Unless exempted by the Authority, every motor car, motor Substituted wagon and articulated vehicle provided by a driving instructor for the purposes of instruction shall be fitted withp. 4120.

(a) duplicate controls that-

- (i) are located directly in front of the seat beside the driver;
- (ii) readily enable the instructor to control the vehicle by effectively braking the vehicle and either disengaging the transmission or switching off the ignition; and
- (b) an approved rear vision mirror fitted in a position approved by the Authority for use of the instructor.

An appeal against a decision of the Authority under section 10 11. of the Act, shall be made by way of complaint, under the Justices Act, 1902, and the grounds of appeal shall be annexed to the summons issued thereunder.

12. (1) A certificate issued by The National Safety Council of Western Australia Incorporated or other prescribed body, for the purposes of section 6 of the Act, may be in the form of the certificate of competency ordinarily given by that body; but every certificate shall set out the class of vehicle in respect of which the certificate holder has been found competent to act as a driving instructor.

(2) For the purposes of the Act and of these regulations, the classes of motor vehicle in respect of which drivers instructors licences and permits are issued are-

- (1) any motor car, or any motor wagon weighing not more than 2 032 kgs unladen;
- (2) any motor vehicle (except a motor cycle or an articulated vehicle);
- (3) any motor vehicle other than a motor cycle;
- (4) any motor cycle.

13A. (1) The Authority may exempt from the provisions of the Act relating to the payment of the prescribed fee an application for a licence or permit from and the issue of a licence or permit or renewal thereof to, a person who is-

- (a) employed by or in the Authority, the police force of Western Australia, the Education Department of Western Australia or a school or institution approved by the Authority and is the holder of a Certificate of Competency issued by The National Safety Council of Western Australia Incorporated (4) of section 7 of the Act; or
- (b) employed as a driving instructor by the Metropolitan (Perth) Passenger Transport Trust, the Western Australian Fire Brigades Board or such other body as is approved by the Authority.

(2) Every licence or permit issued pursuant to this regulation shall have specified in it a condition that the holder will not, until the appropriate fee has been paid, act as a driving instructor other than in the course of his employment with the employer described in subregulation (1) of this regulation.

(3) The holder of a licence or permit issued pursuant to this regulation who acts as a driving instructor otherwise than in accordance with the conditions specified in the licence or permit commits an offence and is liable to a penalty of ten dollars.

Every person who-

- (a) commits a breach of, or fails to comply with, the provisions of these regulations, or fails to comply with any condition to which the issue of a licence or permit is subject; or
- wilfully makes a false or misleading statement or wilfully furnishes any false or misleading information in, or in connection with, an application for a licence or permit, (h)

commits an offence and is liable to a penalty of one hundred dollars.
